6. DIRECTOR'S REPORT

A. "Marketplace on the Green" project

Staff is still working with CBL Properties through our attorney to finalize the details of the land trade agreement. Efforts are being made to close by the end of the year if possible.

- B. TJ Acquisitions Land Donation to Park Commission Staff is working through our attorney to finalize the 9-acre land donation adjacent to Hillbrook Park with the land owner, TJ Acquisitions. Efforts are being made to close by the end of the year.
- C. Michigan Natural Resources Trust Fund Grants
 The Trust Fund Board will meet on December 12 to make the awards for 2018. Under consideration is the Towner Road Playground request.

7. DISCUSSION ITEMS

A. Central Park Projects

Jesse Lewter, Wolverine Engineering and Surveyors, reviewed the design for the Central Meridian Regional Trail Connector and Gateway Footbridge and Restroom Projects with the Commissioners. The final plans will be sent to the DNR for approval with proposed bidding in February.

B. Smoking and vaping rules in parks

The Commissioners engaged in a discussion on the best way to address smoking/vaping in our parks. There were multiple views including adding a rule, changing the ordinance, adding signs throughout the parks, add signs requesting people not to smoke in pavilions or playground areas.

C. Park Signs

The Commissioners discussed the new Township Logo and how it can be integrated into our park signage. The Commissioners agreed that a style upgrade is overdue. Staff will research a few new designs for Park Commission to review and approve. Suggestions included using the new logo but in black and white and do two new signs per year.

D. North Meridian Road Pavilion Ribbon Cutting

As part of the MNRTF grant requirement, we must host a ribbon cutting event to recognize the Trust Fund Program. Staff thought it would be good to hold the event in conjunction with a sledding event while school was on break. The proposed date is December 28, 1-3 pm and will include a bon fire, hot chocolate.

E. Park Commission Rules and Procedures

Director Maisner will review the current document and provide recommended changes for a future meeting.

F. Security in Parks

Following the vandalism that took place recently in Van Atta Woods Park, Chair McDonald requested that the Commissioners have a conversation on how to best deter this type of activity in the future. Currently, our Police Department unlock and then lock the park daily

as well as the restrooms. Our new park signs also provide a phone number for our police department to report this type of activity. Phone tree


Hi all,


