- A. Steve Thomas, Board Member, appointed to the Board in January, is a professional ecologist, is a 15-year resident of the Township, been involved in stewardship within the Township since 2009 and has actively conducted and lead ecological stewardship in Sower Woods for last six years.
- B. Emma Campbell, Land Stewardship Coordinator, hired by the Township in January, holds a Bachelor of Science, Fisheries and Wildlife from MSU, worked as an education and stewardship coordinator and interpretative naturalist for Woldumar Nature Center, and has an extensive background in environmental stewardship including fundraising, grant writing, creation and implementation of land management plans and volunteer recruitment and coordination.

#### 7. OLD BUSINESS

A. Wetland Bank Update

Board Member Lapham reported the Environmental Commission has reviewed the current Ordinance, some changes will be required for wetland banking, and they plan to discuss it with the Environment, Great Lake and Energy Department (EGLE). The Environmental Commission believes the Tihart Preserve would be a good mitigation opportunity and suggested a walk of the property with Mike Pennington. Board Members indicated they would like to be part of that walk.

#### Discussion:

- 1) We can break the tiles to reclaim the wetland
- 2) It was suggested a tour of the land preserves in the spring
- 3) There were discussions during the purchase of the Tihart Preserve on reclaiming the wetland
- 4) Suggestion was made to include Drain Commissioner's Office on these discussions
- 5) It was suggested to flood the area to get rid of canary grasses
- 6) Board Member Lapham will take this information back to Environmental Commission and arrange site visit this spring.

## B. Land Preservation Millage Renewal

Board Members discussed:

- 1) The current Millage expires this year
- 2) Should the renewal be for the current levy amount or should it be at a lower amount
- 3) With respect to millage renewal request, it was stated that a majority of them pass
- 4) Ingham County is currently advertising their Parks and Trail Millage renewal and it will probably pass
- 5) Meridian Township Police and Fire Millage is also up for renewal
- 6) Board Members asked to have this as a March agenda item to be discussed further with staff.

WHEREAS, Roland Harmes' service on the Land Preservation Advisory Board has been beneficial to Meridian Township, its citizens, and its natural environment.

- A. Stewardship Coordinator 2020 Work Plan
  - 1. Management Plan for Invasive Species

Coordinator Campbell outlined goals and objectives for this plan. She will work to remove resistant species in the not very dense sites especially where there is already a nice native species start. She reported she has already worked in Hillbrook Park and will continue 2019 applications to work to remove large knot weed in Ponderosa. If funds available, she suggested an outside company could assist in large areas to remove invasives but she will visit and survey the land preserves first and create a priority list. She has a new GPS unit to assist with mapping treatment areas and will be scheduling workdays in near future (complete plan in minute book).

- B. Introduction of Meridian Conservation Corps
  - 1. Coordinator Campbell outlined plan for the launch of Meridian Conservation Corps (MCC) a township wide volunteer program (complete outline and mock flyer in minute book). MCC is a program devoted to increasing community involvement in our parks and preserves and to grow awareness of volunteer opportunities involving the care and conservation of Meridian Township's expansive local green spaces.
  - 2. Corps Programs will include (full description of each program included in outline):
    - A. Forest Watch, Cleanup Crew, Trail Blazers, Invasive Species Strike Team, Planting a Native Meridian, Waterways Watch, Bioblitz Squad, Vernal Pool Monitors.
  - 3. Coordinator Campbell announced the program will not officially be launched until all the proper resources are in order such as: website creation, resource toolkits for each program, logo creation, and outreach materials (all in collaboration with communications). Official launch date will be Earth Day, April 22, 2020.
