PRESENT: Clerk Dreyfus, Commissioner Deschaine, Commissioner Sundland

(1) CALL TO ORDER

Clerk Dreyfus called the meeting to order at 4:00 pm. Commissioner Deschaine was having some technical issues. There was a slight delay in getting the action items started.

(2) APPROVAL OF MINUTES

Motion was made by Kathy Sundland and seconded by Brett Dreyfus to approve the minutes from the March 3, 2020 and March 5, 2020 meetings. Sundland and Dreyfus voting yes. Commissioner Deschaine was having technical difficulties.

Commissioner Deschaine joined the meeting at 4:15 pm

(3) MOTION TO ESTABLISH ABSENTEE VOTER COUNTING BOARD (AVCB) AND APPOINT INSPECTORS, SUBJECT TO ADJUSTMENTS AS NECESSARY, FOR THE AUGUST 4, 2020 ELECTION.

Motion was made by Commissioner Dreyfus and seconded by Commissioner Deschaine to approve the establishment of the Absent Voter Counting Board and appoint election inspectors, subject to adjustments for the August 4, 2020 election. All members present voting yes.

(4) MOTION TO ESTABLISH RECEIVING BOARD AND APPOINT INSPECTORS, SUBJECT TO ADJUSTMENTS AS NECESSARY, FOR THE AUGUST 4, 2020 ELECTION.

Motion was made by Commissioner Deschaine and seconded by Commissioner Dreyfus to establish a receiving board and appoint inspectors subject to adjustments. All members voting yes.



(5) MOTION TO APPOINT PRECINCT INSPECTORS, SUBJECT TO ADJUSTMENTS AS NECESSARY FOR THE AUGUST 4, 2020 ELECTION.

Commissioner Deschaine was concerned about the mistakes on the list of precinct workers. Deputy Clerk Bigsby explained that the list was not complete due to the number of workers that were accepting and declining because of the pandemic. She would get a better list to him by the 14<sup>th</sup> of July, which was the deadline to have workers assigned to the precincts.

Motion by Deschaine seconded by Dreyfus to approve the list of precinct workers subject to adjustments for the August 4, 2020 election. All members present voting yes.

(6) OTHER BUSINESS

Commissioner Deschaine reiterated that the final list would be available to him by July 14, 2020.
