

**SANITARY SYSTEM BENEFIT CHARGES
LAKE LANSING ROAD AT DAWN AVENUE SANITARY SEWER**

RESOLUTION

At a regular meeting of the Township Board of the Charter Township of Meridian, Ingham County, Michigan, held in the Meridian Township Municipal Building, 5151 Marsh Road, Okemos, MI 48864-1198, 517. 853.4000 on Tuesday, February 23, 2021, at 6:00 p.m.

The following resolution was offered by Treasurer Deschaine and supported by Trustee Jackson

WHEREAS, Section 78-154 of the Code of Ordinances of the Charter Township of Meridian provides for establishment by resolution of a benefit charge to be paid by the owner of premises to be connected to Township sanitary mains when the premises to be connected has not been specially assessed for the construction of said sanitary main, and;

WHEREAS, in 2020, a sanitary main was constructed across Lake Lansing Road at Dawn Avenue to serve Parcel 33-02-02-08-201-001, located at 2723 Lake Lansing Road, and was not paid for by a SpecialAssessment;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE CHARTER TOWNSHIP OF MERIDIAN, INGHAM COUNTY, MICHIGAN, THAT

1. The installed cost of the sanitary main across Lake Lansing Road at Dawn Avenue has been set at \$16,280.89.
2. The installed sanitary main only benefits Parcel 33-02-02-08-201-001, located at 2723 Lake Lansing Road.
3. The benefit charge is hereby established at \$16,280.89 for 2021 (plus 5% annual increase).
4. The sewer benefit charge established herein shall have immediate effect.


