MINUTES (DRAFT)

ENVIRONMENTAL COMMISSION

June 2, 2021

Attending: Commissioners: Anna Colby, Tom Frazier, Kendra Grasseschi, Ned Jackson, Bill McConnell, Bernadette Osborn, Annaka Saffron, John Sarver, Courtney Wisinski, Luka Wisinski,; Staff: Samantha Diehl, Stephen Gebes, and LeRoy Harvey, and Tim Schmitt; Guests: Joell Ackerman, Audrey Hirchert-Walton,

Approval of the Agenda: Jackson motioned to approve. Seconded by Grasseschi. Unanimously approved.

Approval of Minutes: Jackson mentioned that he will send a few typo corrections to LeRoy. Colby motioned to approve. L. Wisinski seconded. Unanimously approved.

Welcome to Meridian's New Planning Director: Tim Schmitt shared that he is a planner by trade with a strong environmental and interests. He has a minor in Environmental Science, is on the Board of Michigan Energy Options, and started in a community with a strong wetland ordinance. Schmitt expressed enthusiasm about working with the Environmental Commission.

Wetland Discussion: Grasseschi and Trustee Wisinski provided a memo in the <u>June Packet</u> inviting the E.C. to review its roles. C. Wisinski has been reviewing the ordinance, gaps, wetland maps, and talking with others about next steps. C. Wisinski suggested that education of residents, developers, and staff is a first step. She suggested that the E.C. could be a sounding board asked about the process of review. The E.C. has not reviewed many wetland use permits in the last few years. McConnell mentioned that most wetland mitigation efforts have been successful (we've never had to withhold a bond). Jackson mentioned that it's hard to evaluate the long term effectiveness of mitigation and that we've often relied on the Environmental Consultant's advice. We regulate down to 1/4 acre and it is possible that wetlands smaller than this are being lost. He also mentioned that the Board has typically followed our recommendations. Sarver mentioned prior discussion about wetland banks as another tool we've explored. Colby asked for clarification about net loss and quality of wetland mitigation. Wisinski mentioned that our goal of no net loss requires a 2 to 1 replacement. Sarver mentioned that many homeowners may not know or care that they have wetlands in their backyards. Grasseschi described that our current wetlands have been stressed and perhaps buffers have been destroyed. She described this as an environmental justice issue and used the Midland dam break as partially due to wetland loss. Frazier looked at the State regulations and discovered that we currently have to use the State's definition. He suggested that we move forward on updating our ordinance. McConnell mentioned that the presence of wetland species is part of the definition. If the flood plain or wetland has been converted, it may no longer have wetland species. Wisinski reminded the Commission that it can be more stringent than the State. She asked about enforcement, especially if areas have been destroyed and buffer strips mowed. Grasseschi mentioned that there is a notice that is included tax bills. She also described the connection between wetland preservation and climate change. Frazier mentioned that local governments with wetland ordinances must grant permits unless the wetland is "essential to the preservation of the community's natural resources." McConnell mentioned that it's rare that our Township has rarely declared a wetland non-essential.

Next Steps:

- Update the ordinance. See original edit suggestions <u>here</u>.
- Learn from communities with successful wetland ordinances
- Explore treatment of detention basins may be an opportunity to reestablish wetlands. C. Wisinski mentioned that the Drain Commissioners office may be amenable to this idea.

- Become familiar with our ordinance and comparable ordinances and explore gaps and opportunities. 40 local governments in Michigan have local ordinances. Several are nearby including Williamstown Twp, East Lansing, Delhi Twp. with numerous others in Oakland and Washtenaw.
- Educate staff and residents about wetlands and buffer strips (under "water features" 47-261).
- Explore the 1-Water Campaign described by SEMCOG. Explore partnerships with Tri-County Regional Planning Commission.
- Seek student involvement through the Earth Club.
- Explore relationship to green infrastructure and Cliff Walls' list of recommendations as we move forward.
- Learn more about and share relationships between human and green infrastructure.
- Explore classes and other learning opportunities at the high school level
 - o Advanced Placement Biology Class at Okemos High School
 - Environmental science course (Dave Chapman, instructor). She has been researching wetlands on her own as well. She feels that schools could do more to encourage students to research on their own – and provide them will the tools to do so.
 - o Partnership with the Meridian Conservation Corps.
 - Field trips
- Work with students to review the Wetland ordinance and suggest changes and/or what the Board could do to help. C. Winsinski offered to help facilitate.
- Invite Schmitt to join us at a future meeting to his experience with other communities with wetland ordinances as well as any recommendations that he might have about education of staff.
- Check with the Drain Commissioner's office about talking with us. Carla Clos is a good contact (prior Environmental Commissioner).

Green Infrastructure Grants for Schools: Harvey shared some pictures from Rose Vadnais of the progress at Radmoor Montessori. He also shared some pictures from Haslett Middle School. Sarver suggested that we invite the teams to present at a future Green Dialogue.

Tree Team: Harvey reported that 300 trees were distributed during May with help from our Green

Team and volunteers.

Staff Report: Harvey shared a picture of volunteers at the market "green resources table." Harvey mentioned the availability of rain barrels, the Michigan Sustainability Conference, an upcoming planting and weeding hour in the roundabout, and new water barrels at the Briarwood Community Garden. He shares these updates in the Green Gazette. Subscribe at http://bit.ly/gg-directory. McConnell asked Harvey to elaborate on the rain garden in the roundabout and challenges with maintenance (such as on-going weeding). A resident on NextDoor complained about its appearance which sparked a heated conversation, most in support of native plantings. Harvey also mentioned the possibility of a mini-grant program to support local green infrastructure projects and provide

Board of Trustees: C. Winsinski mentioned that the Board is talking about wetlands and trees. She is talking with Treasurer Phil Deschaine about including the wetland brochure in future tax or utility bills. There are some new developments which are sparking discussion about wetlands. There is a community survey that is being developed. She mentions that there may still be time (a couple weeks) to provide input.

Brownfield Redevelopment: Jackson reported that the May 20th meeting was cancelled but there was a part for Mark Kieselbach.

Energy Team: Energy Team members are seeking information that may be helpful for related to the Citizens' Climate Commitment. The Energy Team will be presenting at the June 9th Green Dialogue at 9am.

Environmental Justice: Grasseschi spoke at the Michigan Environmental Justice Summit. Rose had posted a link to this conference. See presentations <u>on-line</u>.

Green Team: Frazier reported that the Green Team is meeting Thursday at the Pavilion

Planning Commission: McConnell reported that the Commission met on May 24. There were two public hearings. One was about a property near the Meridian Company (1999 Saginaw) to rezone from commercial to industrial. The other was about a mixed planned unit development ordinance.

State of Michigan: Frazier reports that there are some issues of potential concern at the State level regarding local control of sand and gravel mines as well as vacation rentals/air B & Bs.

Transportation Commission: McConnell reported that the Commission has been focused on the pathway plan and road improvements. There is also some discussion about railroad quiet zones.

Adjournment: Colby moved to adjourn. Seconded by Grasseschi. Unanimously approved at 8:33 PM

Staff Update: July 2021

I will be out of town in the U.P. next week with questionable Internet connectivity. I may or may not see you Wednesday for the Green Dialogue and/or E.C. meeting. Have fun!

Solar on the Service Center: Work should begin this month. HOMTV and our Communication Staff are interested in doing stories about the progress.

Green Gazette: The latest Green Gazette was distributed July 1st. View at https://conta.cc/2Tm7sLC If you have story suggestions or questions, please contact LeRoy. The Green Gazette has other updates I won't report here.

Green Neighbors Network: Sarah, Kendra, and I discussed a bi-annual pow-wow with Green Neighbors to check in and discuss topics of interest. We also agreed to review the list of neighborhoods/groups represented and compare to Amber Clark's updated neighborhood list. If any of you would like to help with this, let me know.

Wetland Discussion: Kendra shared some helpful wetland links with our Student members/alternates and one or two of them may share a report at our meeting this month. Kendra has been discussing next steps with Courtney. LeRoy and Cara (our GIS Specialist) are investigating the latest wetland data from the State of Michigan. Cara will likely have additional data to share before the meeting (more fine-grained data by wetland types over time). Tim Schmitt, our new Planning and Development Director, share some sample wetland ordinances with us and has offered to speak with us when we or anyone is ready. Some time we might brainstorm our duties (what's working? opportunities? etc.)


- Advise the Township Board, Planning Commission, and Director of Community Planning and Development, as necessary, on wetland use permits, appeals of wetland use permits, and mitigation plans.
- Serve in an advisory role in setting policy guidelines on wetland issues in the Township.
- Identify conflicts and propose solutions to resolve conflicts regarding wetland protection by present Township ordinances, Township operating procedures, and Township activities.
- Identify and propose solutions to problems associated with wetland management.
- Provide recommendations to the Director of Community Planning and Development on map administration.
- Assist landowners who are interested in the voluntary protection of wetlands.
- Promote wetland education at all levels. Develop education programs for the public and for Township schools.
 The program should promote the values of wetlands and awareness of the hazards and threats to wetlands. The program should be particularly targeted to landowners withwetlands and emphasize how best to protect wetland values on their property.
- Coordinate a voluntary wetland stewardship program. Develop an adopt-a-wetland program for interested citizens to participate more directly in preservation of specific wetlands.

Finally, <u>here's a link to the ordinance edits</u> (to bring our Code in line with the State). We had discussed bringing this to the Board when we were ready with other suggested Code updates, such as the Green Infrastructure Audit.

Green Dialogue: Green Dialogues continue every Wednesday at 9am for an hour (or however long you choose to tune in). Once a month or more, we will have guest presenters on topics of interest. Emma Campbell has agreed to speak on July 21st. I've created a "landing page" https://bit.ly/green-conversation which provides general info you can share with others.

Recycling Center: I've asked for a request for quotation from one design firm (for improvements to the Recycling Center. We have not determined the feasibility of Granger's offer to provide compactors/containers for another location. Proximity to our offices may be key, based up the need to keep the space tidy and functional. Locations such as the Service Center, North Mall lot, or the Municipal Complex may be more desirable.

Below are the results for the on-line vs. in-person survey some of you participated in. One idea: Meet in-person quarterly and online (or hybrid) in the other months if we can do this legally. Perhaps understanding when in-person is required could help – for example if we're reviewing a permit or making policy changes. Most of our work is recommendations, so we may have more flexibility.

§ 86-471 Setbacks from water features. [Code 1974, § 83-1.11; Ord. No. 2007-12, 10-28-2007]

- (a) Generally. Recognizing the special conditions and relationships in transition areas between water features and developed areas, minimum setbacks are hereby established to prevent degradation of the water features of the Township, provide protection during high-water episodes in floodprone areas, and preserve the aesthetic values of water features. This regulation is based on the police power, for the protection of the public health, safety and welfare, including the authority granted in the Michigan Zoning Enabling Act PA 110 of 2006 (MCL § 125.3101 et seq.).
- (b) Structure and grading setbacks. All structures and grading activities shall be setback from the edge of a water feature as follows:
- (1) Wetlands regulated by the Township, the state, or by federal law equal to or greater than two acres in area; 40 feet. The Township may require the permit applicant to have the precise boundary of the wetland in question delineated in accordance with Chapter 22, Article IV of this Code.
- (2) Wetlands regulated by the Township, the state, or by federal law equal to or greater than one-quarter acre in area but less than two acres in area: 20 feet. The Township may require the applicant to have the precise boundary of the wetland in question delineated in accordance with Chapter 22, Article IV of this Code.
- (3) The Red Cedar River: 50 feet, as measured from the ordinary high-water mark on the side of the river where the structure is to be located or grading activity is to occur.
- (4) Open county drains or creeks: 50 feet, as measured from the top of the bank on the side of the drain where the structure is to be located or grading activity is to occur.
- (5) Lakes equal to or greater than two acres in area: 40 feet, as measured from the ordinary high-water mark.
- (6) Lakes equal to or greater than one-quarter acre in area but less than two acres in area: 20 feet, as measured from the ordinary high-water mark.
- (c) Natural vegetation strip. To minimize erosion, stabilize streambanks and wetland edges, protect water quality, and preserve fish and wildlife habitat, a natural vegetation strip shall be maintained from the edge of a water feature as follows:
- (1) Wetlands regulated by the Township, the state, or by federal law: 20 feet. The Township may require the permit applicant to have the precise boundary of the wetland in question delineated in accordance with Chapter 22, Article IV of this Code.
- (2) The Red Cedar River: 25 feet, as measured from the abutting ordinary high-water mark.
- (3) Open county drains or creeks: 25 feet, as measured from the top of the abutting bank.

- (4) Lakes: 20 feet, as measured from the ordinary high-water mark.
- (5) Existing soil and organic matter shall not be altered or disturbed within the natural vegetation strip.
- (6) Natural ground cover shall be preserved to the fullest extent feasible, and where removed shall be replaced with other naturally occurring vegetation that is equally effective in retarding runoff and preventing erosion.
- (7) A lawn shall not be considered a natural vegetation strip.
- (8) Application of organic or synthetic pesticides, fertilizers, or other chemicals shall not be permitted in the natural vegetation strip.
- (9) Planting of perennial native species in the natural vegetation strip is encouraged, especially where exposed soil and steep slopes exist and in reforestation efforts.
- (10) Within the natural vegetation strip, trees, shrubs, and ground cover may be selectively pruned or removed to provide reasonable private access or views to water features, to remove potentially hazardous or nuisance exotic vegetation, and to improve or protect wildlife habitat. Such pruning and removal activities are subject to the following:
- a. No more than 10% of the length of the strip shall be clear cut or mowed to the depth of the strip.
- b. Pathways accessing water features shall not exceed 10 feet in width.
- c. A live root system shall be maintained to provide for streambank stabilization and erosion control.
- (d) Exceptions. The following exceptions shall apply to this section. All uses that fall within such exceptions must comply with all other requirements and standards of this chapter and all other applicable regulations and laws.
- (1) Subsection (b) of this section shall not apply to the following:
- a. Plats that have received Township preliminary or final approval prior to September 2, 1991.
- b. Site plans and condominium plans that have received final approval prior to September 2, 1991.
- c. Unplatted lots under two acres in area, created prior to September 2, 1991, on which an occupiable building is located for which a building permit was issued prior to September 2, 1991.
- (2) For plats that have received Township preliminary or final approval between September 2, 1991, and the effective date of this division, for site plans and condominium plans that have received final approval between September 2, 1991, and the effective date of this division, and for unplatted lots under two acres in area created between September 2, 1991, and the effective date of this division on which an occupiable building is located for which a building permit was issued between September 2,1991, and the effective date of this division, the requirements of subsection (b) of this section shall be modified to provide that when a forty-foot setback is required, decks, porches, and patios may project a maximum of 10 feet into the required setback.

- (3) The limitations as to grading activities in subsections (b) and (c) of this section shall not apply to the following:
- a. Plats that have received preliminary or final approval prior to the effective date of this division, including littoral rights running with platted lots.
- b. Site plans and condominium plans that receive final approval prior to the effective date of this division.
- c. Unplatted lots under two acres in area, created prior to the effective date of this division, on which an occupiable building is located for which a building permit was issued prior to the effective date of this division, including littoral rights running with unplatted lots.
- (4) The limitations as to grading activities in subsections (b) and (c) of this section shall not apply to grading activities required by the Township Engineer under the Township's land development ordinances and regulations.
- (5) Bridges, docks, piers, sea walls, or wharves, incidental to the permitted uses of the zoning district in which a protected water feature is located are exempt from the water feature setback.
- (6) Structures that do not require a permit from the Township incidental to the permitted uses of the zoning district in which the protected water feature is located are exempt from the water feature setback.
- (7) County drain commission normal activities including, but not limited to, drain cleaning, dredging, depositing, and grading of dredge spoils are exempt from the water feature setback. The adverse effect on the natural vegetation strip shall be minimized.
- (8) Landscaping and lawn maintenance incidental to the principal use are permitted in the water feature setback, excluding the natural vegetation strip.
- (9) Other activities are exempt from the water feature setback to the extent the Township is prohibited from regulating by its ordinances or other laws.
- (10) Subsections (b)(1), (2), and (c)(1) of this section shall not apply to any driveway, pathway, or sidewalk less than or equal to 12 feet in width and/or utilities that have been granted a permit to pass through a state department of environmental quality (MDEQ) or Township-regulated wetland. The exception shall apply only to the areas of the setback and natural vegetation strip which the driveway, pathway, sidewalk and/or utilities must pass through as it enters and/or exits the wetland. All conditions of the MDEQ or Township permit shall be met.

<u>Brief Research Statement:</u> My interests border on wide ranging topics including issues about research subject/participant selection; biomedical research partnerships between Africa & the West; environmental science and public policy; environmental justice/racism; eugenics; science of life extension; and morality in primitive cultures. Specifically:

- A. My 2018 book, Clinical trials and the African person, is an adaptation of my doctoral dissertation which strives to complement scholarly literature dealing with cross-cultural biomedical ethics and emphasizes the African perspective. In it, I aimed to re-conceptualize responsibility in international clinical trials with the insight of the African notion of "self."
- B. With a multidisciplinary perspective, I explore *more broadly*, a range of questions pertaining to moral philosophy, health ethics/bioethics, with attention to their practical implications. I explore areas of environmental health and environmental ethics, public policy and the role these play in moral thinking. My research and teaching interests include issues about research ethics; subject/participant selection; human experimentation; consumer right to know; morality in primitive cultures; environmental ethics; environmental health; and environmental justice/racism.
- C. I participated in the research project, *Overview of a three-year Man Up Man Down Dental Fare (2016-2018): Process and Outcomes.* It led to a product that provides a process and outcome

analysis of the Man Up Man Down (MUMD) dental fair conducted each of the following years – 2016, 2017, and 2018.

- D. As part of a study team, I have researched *The Men Are Now United Program ("MANUP"): A Diabetes Self-Management Program for Black Men.* This empirical study describes the findings of the MANUP focus groups, conducted at MSU Flint with 17 participants across three 5 6-person groups. The research has gathered feedback on participants' lived experience with diabetes and diabetes management, their preferences for diabetes-related education and information, the role of doctors and social support, and their initial ideas for messages for a text-message based diabetes self-management intervention.
- E. I have studied the Food Choices and Public Health: Cultural & Environmental Factors Affecting the Eating Habits of Low-income African American Adolescent Males in Flint. It is a project within my larger vision of Raising Opportunities through Choices (ROTC). I aimed to scale it up to a large project and attract a high-profile funding which will enable me to phase it over three years. Also, R2D2 program seeks to address the NIH's concerns regarding the shortage of physician scientists from groups underrepresented in medicine (URiM).
- G. I am Co-investigator (PI, Michael O'Rourke) in a travel grant awarded by the MSU Alliance for African Partnership titled, "Developing an IRB at University of Nigeria: A Culturally Relevant Model." This exploratory grant lays the foundation for an NIH-R25 that we are re-submitting and titled, "Growing Research Ethics Environments in Nigeria" (GREEN). This initiative breaks new ground by formulating research ethics principles that authentically reflect Nigerian and African values. GREEN will be developed and sustained by blending gold standard research ethics principles with community-based participatory research (CBPR) principles and the NIH Roadmap, resulting in bio-eco-communalism, BEC (an African philosophical construct that describes the immersion of the individual within his/her community and surrounding environment). GREEN leverages the collective strengths of MSU and UNN faculty who are national and international experts in bioethics, medicine, public health, law, science, and education. Notably, GREEN will collaborate with MSU to run series of RCR workshops, seminars, and short courses.
