6. OLD BUSINESS

a. Approval-Form Based Code Letter to Planning Commission
Director Clark and Chair Foster reviewed the letter supporting Form Base Code. Director Clark reviewed Planning Commission Chair Hendrickson's presentation from last meeting. The group discussed the letter. They agreed the letter was excellent. One grammatical change was suggested in the third paragraph of the letter. Change the word generates to generate.

7. NEW BUSINESS

a. 2021 CIA Goals and Work Plan

Director Clark reviewed the six main draft goals, 8 tasks to drive the completion of the goals and 13 objectives. Discussion on the goals included surveying businesses on their priorities. It was discussed to review one to two goals at each CIA meeting and increase business and resident involvement at meetings. Also, making the following three changes:

- Add “not in any particular order”
- Spell out SWOT to strengths, weaknesses, opportunities, and threats (SWOT)
- Change the wording in goal 2 to read: Encourage the development of a common vision for the Corridor businesses through dialogue with businesses and residents.

MOTION BY MEMBER PEFFERS TO APPROVE THE AMENDED 2021 CORRIDOR IMPROVEMENT AUTHORITY GOALS. SUPPORTED BY MEMBER GOETZ. MOTION PASSES 5-0.

b. MDOT Letter Response

Director Clark reviewed the comments from MDOT. They included the following:

- The request for pedestrian crosswalks are under review.
- They are not considering bike lanes at this time.
- Additional lighting would have to include local funding.
- Speed limit reduction can ultimately lead to increased crashes.
- A traffic study will be done for the Montrose traffic signal request.

There was discussion regarding the Montrose traffic study and that perhaps the study should not just be limited to Montrose. Director Clark suggested a follow up letter be sent and to request they attend the next CIA meeting to discuss and clarify the issue.

MOTION BY MEMBER PEFFERS TO APPROVE THE CREATION AND SENDING A LETTER TO CLARIFY THE MONTROSE/SHORT ISSUE WITH AN INVITATION TO ATTEND THE NEXT CIA MEETING. SUPPORTED BY MEMBER ROSS. MOTION PASSES 5-0.

8. DEVELOPMENT PROJECT REVIEW

a. Woda Cooper

Plans have been submitted for this low to moderate income development behind Whole Foods. It will be coming to the Planning Commission soon.

b. Buddy's Pizza

This development is moving forward and working on storm water improvements for the site. Permits have been approved for the work in the floodplain.

c. Other Current Development Projects

Director Clark discussed the following:

- The Mall is having increased activities. Gilbert's Chocolates has left the Mall.
- Little Emil's will be opening at the Mall in the former A & W location.
- Juice Nation has opened on Okemos Road.
- Hungry Howie's is moving from Haslett Village Square to Okemos and Grand River.

- Haslett Marathon is scheduled to begin construction on April 5th.

9. REPORTS

a. Township Board

Supervisor Styka reported the following:

- Expanded deer management program was successful with 326 deer.
- The once every 3 years citizen survey is moving forward.
- The 2nd year of the local road program is underway.
- Rezoning at Jolly and Kansas was denied at the Planning Commission Meeting.
- Recreational marihuana discussion is ongoing.
- Installing new Township entrance signs. One will be at the beginning of the CIA.
- Diversity, equity and inclusion committee is underway.
- The Police Department began a new partnership with Community Mental Health to provide telehealth mental health services when needed.

Re: MDOT Letter Response- Grand River Avenue Pedestrian Crosswalks

Staff provided a virtual meeting with MDOT and the Corridor Improvement Authority to discuss the joint commission letter submitted to them in August. The meeting was well received with MDOT providing details of what they could do and prioritize in the immediate for the approved project of milling and resurfacing Grand River in 2022.

August 25, 2020 the Corridor Improvement Authority in a joint effort with the Transportation Commission of Meridian Township submitted a letter to the Michigan Department of Transportation to highlight the conditions on Grand River Avenue (M-43) that could be improved with the approved plan for construction on Grand River in 2022. The approved milling and resurfacing of Grand River will include the raising of M-43, updates to the Meijer Guttenberg Drain that runs along Grand River and deposits the rain water runoff into the Red Cedar River. The joint letter submitted by the two committees received a response from MDOT regarding what was feasible and how the improvements could be implemented.

Many of the requested elements could be included in future projects for MDOT with Meridian Township as the major financier for those improvements. Specifically improvements for:

- Bike lanes on Grand River from Park Lake to Oak Pointe Court
- Additional streetlights form Park Lake to Dobie Road

A major discussion point were the agreed approved pedestrian crosswalks MDOT is willing to provide in the Grand River project in 2022. As suggested MDOT is proposing 4 pedestrian cross walks to be installed on Grand River in 2022. The request from MDOT is to review and provide input to the locations from the Corridor Improvement Authority and members of the public. The four locations are:

- 2200 Block of W. Grand River Ave near Campus Hill
- 2000 Block of W. Grand River Ave in front of McDonald's and Meijer
- 1800 Block of W. Grand River Ave near Washington Heights
- 1900 Block of W. Grand River Ave near Urgent Care



Recommendation: Motion to submit a letter of recommendation to Michigan Department of Transportation in support of pedestrian crosswalk locations on W. Grand River Avenue.

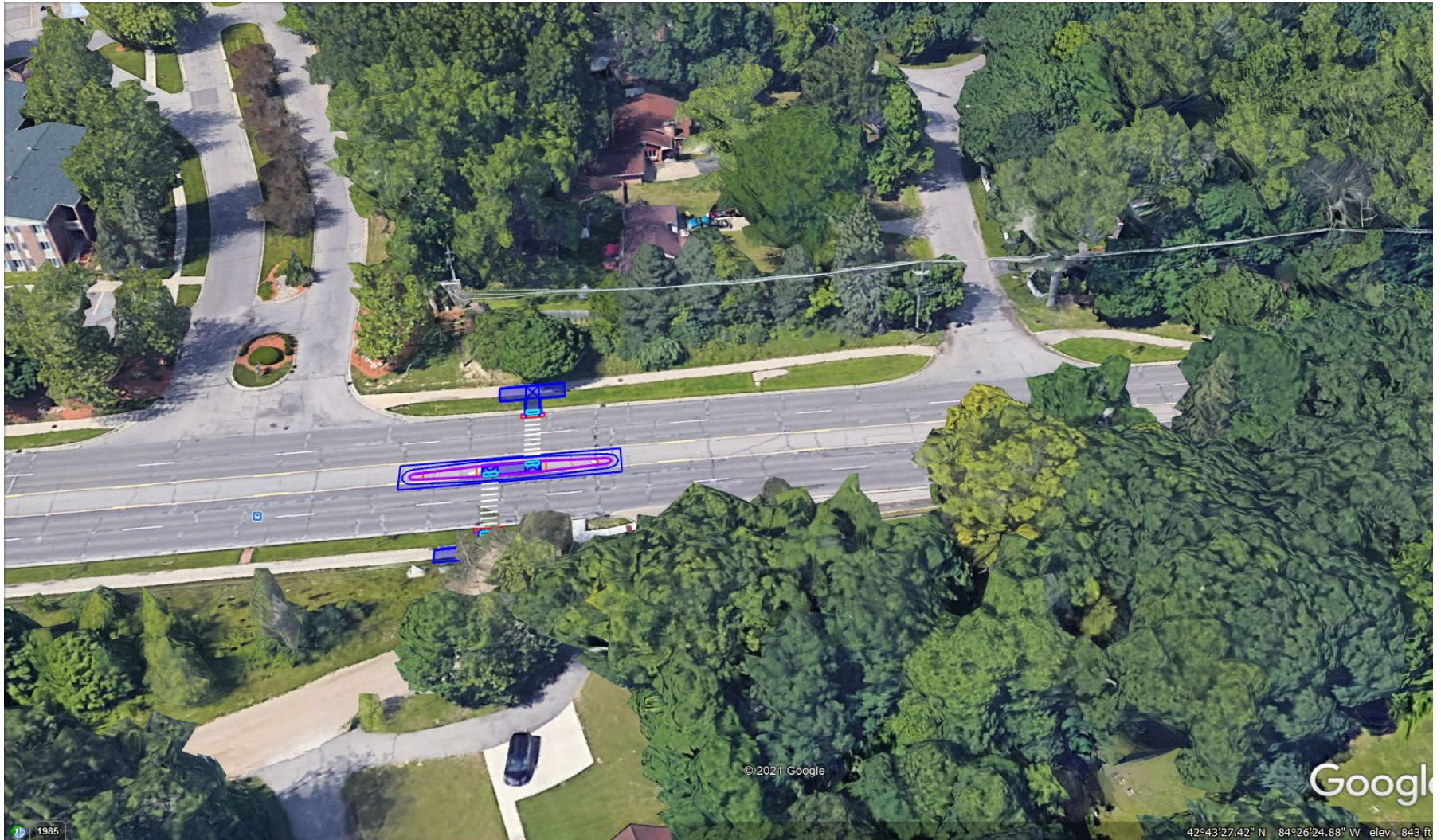

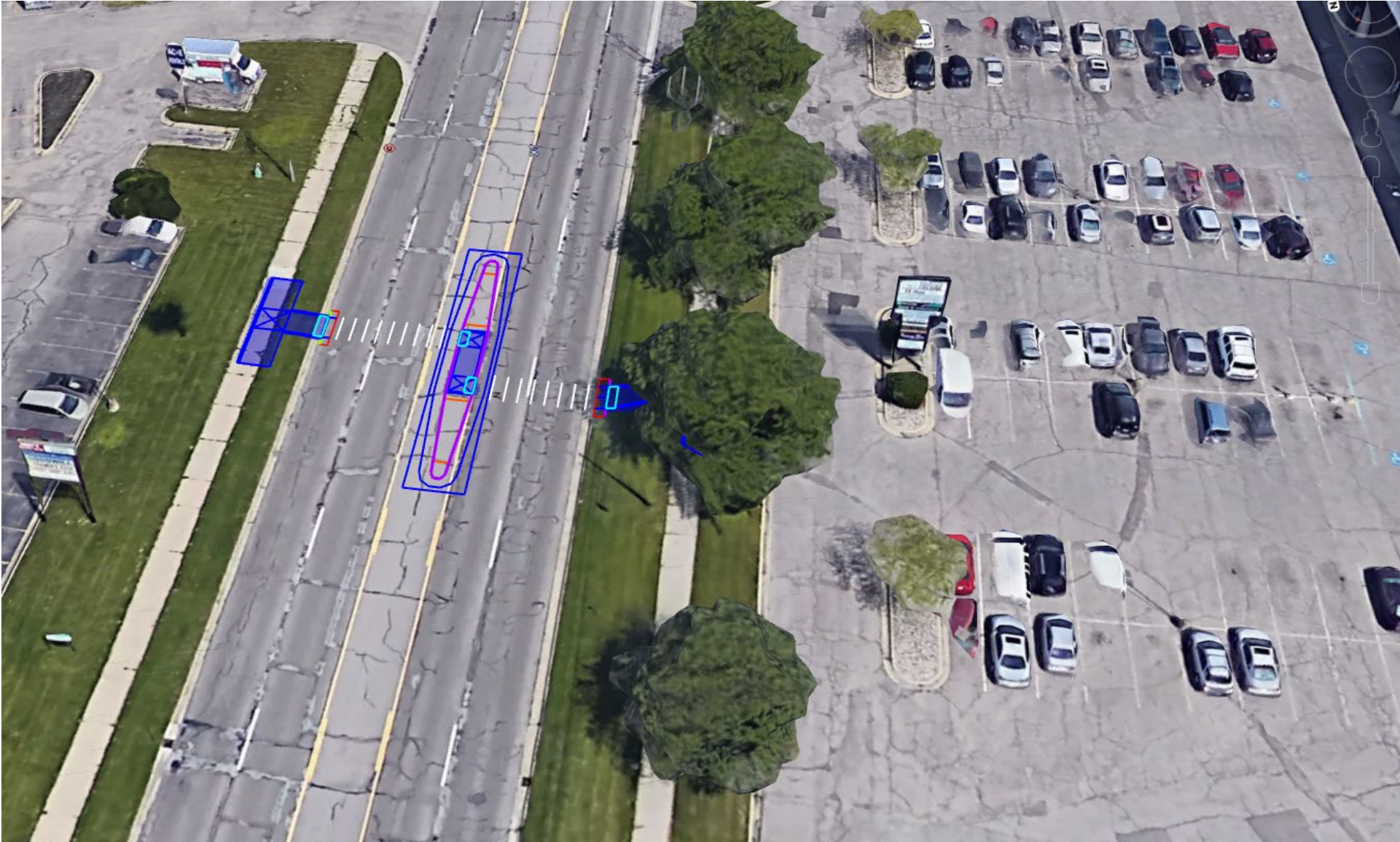

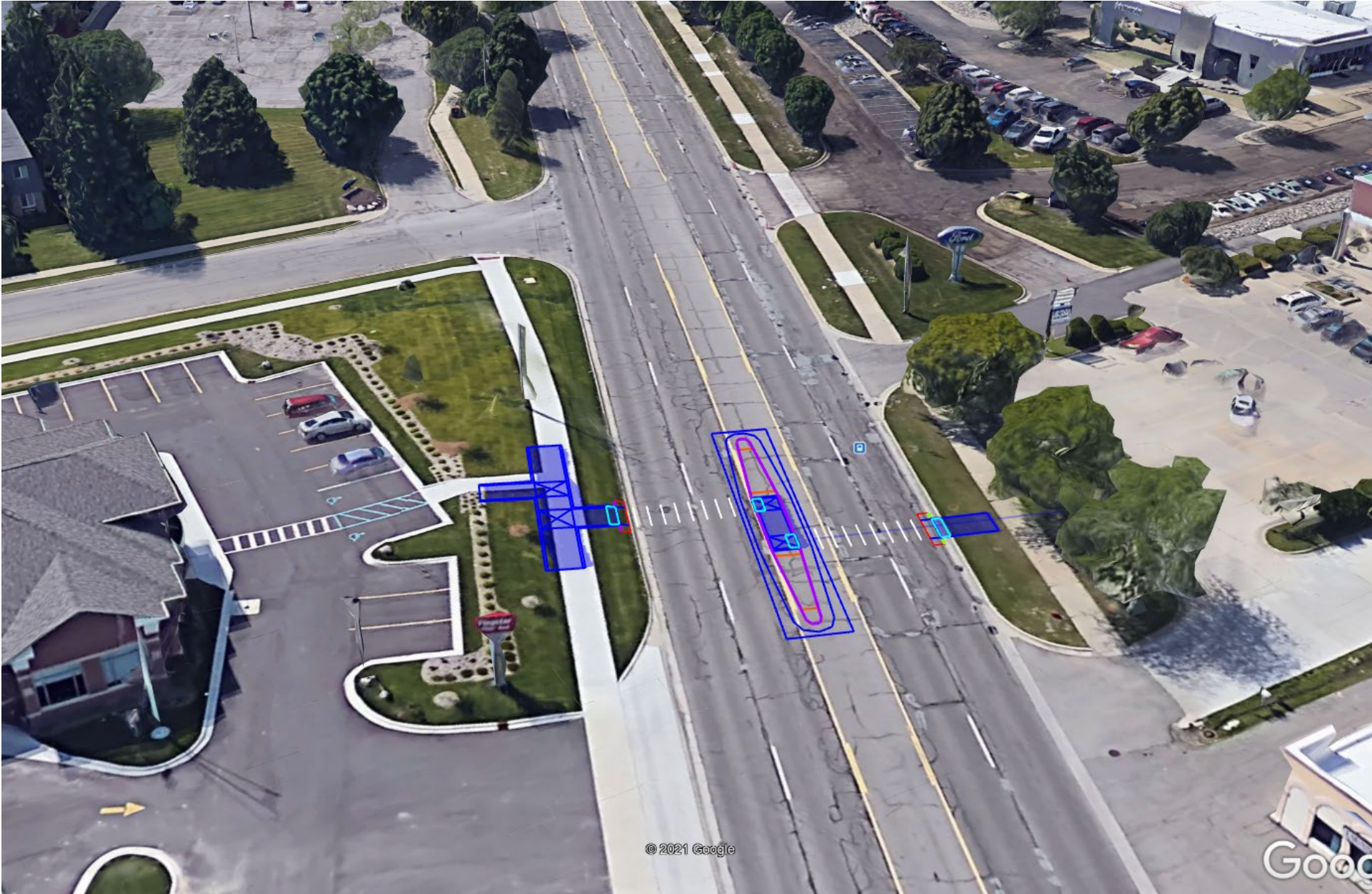

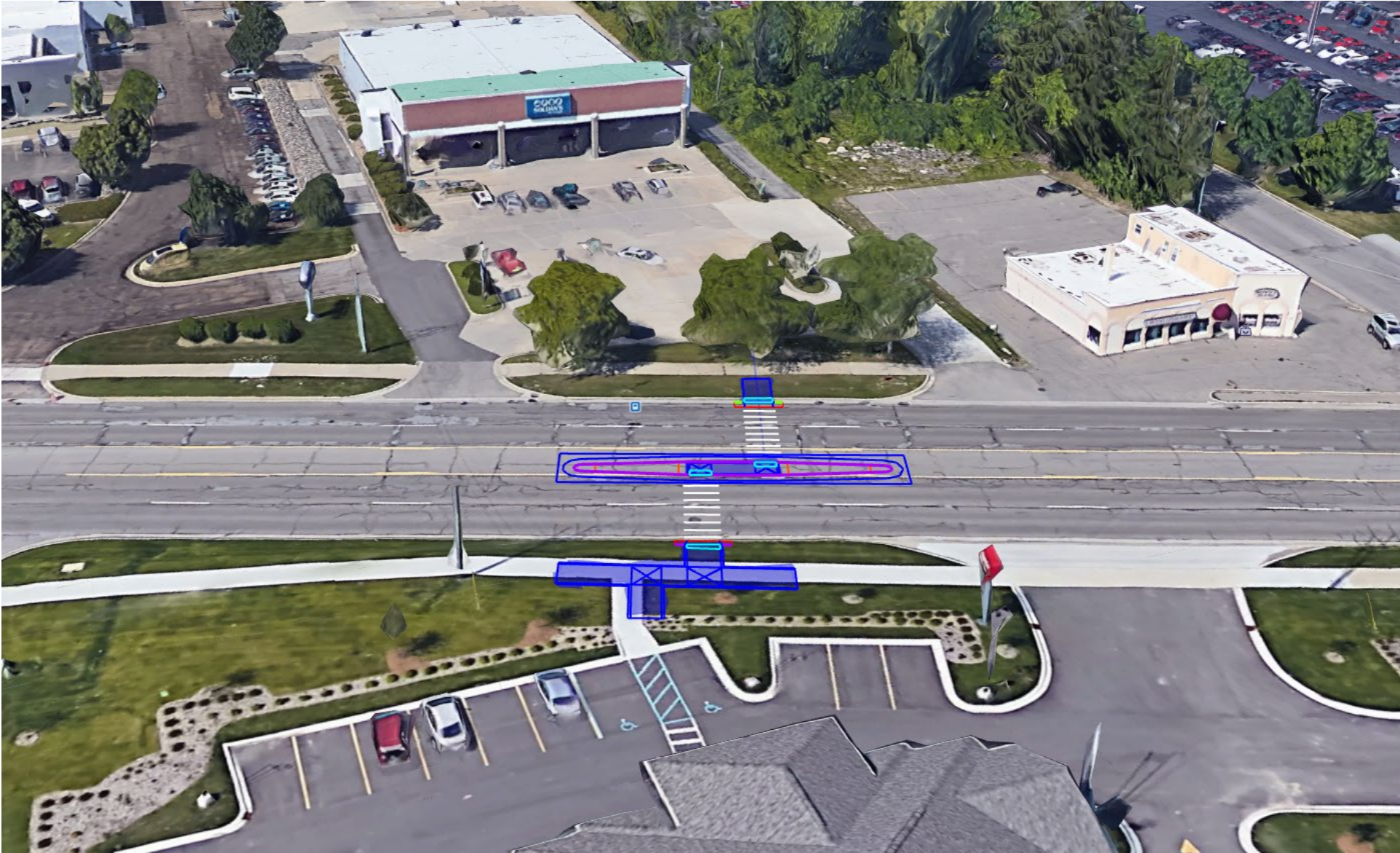
