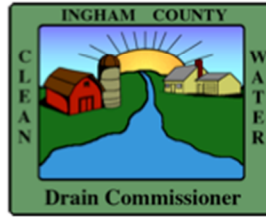

# UPCOMING CONSTRUCTION NOTIFICATION

## FOREST HILLS NEIGHBORHOOD

On March 29th, 2022, Hoffman Bros. Inc. plans to begin construction in the Forest Hills neighborhood as part of the Daniels Drain construction project. The streets of Northview, Hillside, Marlborough, and Eastwood Drives will be pulverized, storm sewer will be installed under the center of the roadway, and ditch grading will take place adjacent to the road within the right of way. Impacted roads and residents and the staging of the upcoming construction can be seen on the map on the last page. Construction in the area is estimated to continue through the end of June 2022, weather permitting.

Before construction takes place, the ends of your driveways will be sawcut within the limits of the right of way if your driveway is adjacent to construction activities. The ends of your driveways are to be saw cut and removed to install new storm sewer, new culverts, and to tie driveways into newly paved roadways. Driveways will be replaced in kind (i.e. an existing asphalt driveway will be repaved with asphalt and an existing concrete driveway will be repaved with concrete). However, due to Ingham County Road Department standards, all concrete drives will end at least 2 feet short of the road edge and asphalt will be used to tie into the road. This is intended for consistency county-wide. Often with concrete driveways ending at the road edge, the driveway and/or ICRD's plowing equipment can be damaged by winter plowing at the concrete edge and can be a safety concern for ICRD's plow operators. A temporary gravel surface will be installed during the existing driveway removals and the construction of the new driveway.

There may be times during the day when construction momentarily obstructs access to driveways. The contractor is to notify residents 24 hours prior to any prolonged obstruction to driveway access. But all driveways will be made accessible by the end of each day. If you see construction nearing your driveway, and you have concerns about accessing your driveway during the day, please communicate with the construction inspector and contractor and we will be happy to accommodate your needs.

Garbage removal may be impacted during these construction activities. If this occurs, the contractor will move garbage bins from the curb to a designated pick-up location as construction activities take place near your home. Please just put your garbage out as you normally would, and the contractor will take it from there.

Access for mail and delivery services may become obstructed during construction as well. If this occurs, the contractor will notify the affected residents and provide a drop-off station down the street that will be compartmentalized for mail and deliveries for each obstructed home.
