REOUEST

The Meridian Township Parks and Recreation Department is seeking proposals for quotes for floating islands that are designed to utilize plant uptake to help filter pond water. The islands need to help reduce the water pollution and to provide habitat for fish and other wildlife. The islands should float and adjust themselves to changing water levels.

The Contractor shall furnish all materials and shipping. Installation will be performed in house by Parks staff. If your company does provide installation, please provide a quote separately.

BACKGROUND

1990 Central Park Drive is located in Meridian Township, Michigan (Okemos). The existing pond filters storm water runoff from the adjacent Meridian Mall and is in need of improvement.

SCOPE OF WORK

Provide quote for floating islands/bio-islands that are 7-10' wide and a total of 50' in length.
Deliver all materials
Provide all information relative to the floating islands (layers of matrix, UV protection, buoyancy
and anchor plates).
