Manager Diehl discussed the staffing issues regarding the internship and how it is difficult to retain talent when the internship is unpaid.

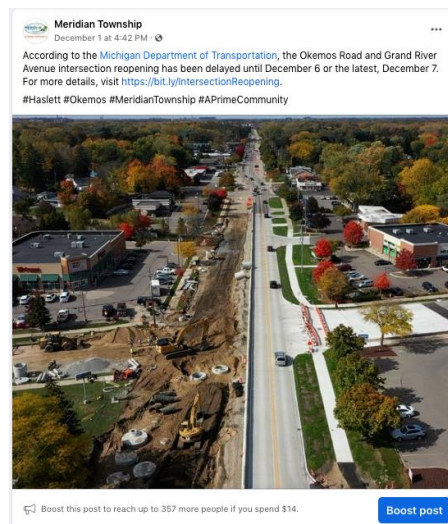
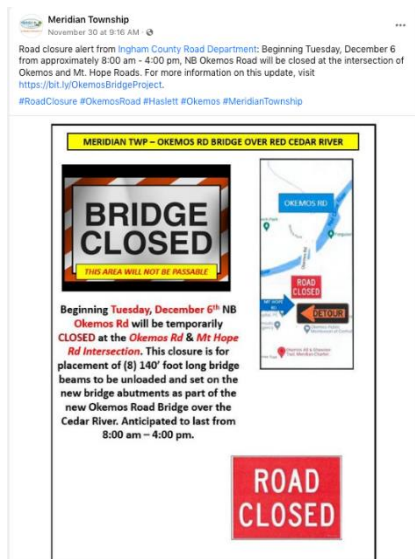
### Staffing Changes

The Multimedia Production & Operations Specialist position was filled the first week of October 2022. There were 15 total applicants, and on October 5, Manager Diehl and Human Resources Director Abby Tithof conducted interviews with four candidates (two internal, two external). Former HOMTV intern Danneisha McDole was offered the position and accepted. Danneisha's first day was October 17.



### Road Construction Updates

Communications Staff continues to provide constant road updates for the Okemos Road Bridge project and the Grand River Avenue enhancement project. Last month, updates provided about the 2022 Local Roads Program concluded for the year. Though the projects are nearing completion, the status constantly evolves due to supply shortages or weather issues. The Public Works and Engineering Department works to keep the Communications Department informed so that information can go out in a timely manner.

**Town Hall Room A/V Upgrades Project**

The partial installation of the Town Hall Room was completed at the end of November 2022. The Town Hall Room now has 7 new television monitors, 12 new microphones, 10 individual monitors at each dais seat, a new lectern, a new audio/video mounted rack, and updated audio wiring. The final video distribution control panel is expected to arrive in December 2022. Once that piece is delivered, Smart Homes/Smart Offices needs about two more days of work to complete the full installation. Even though the final piece is missing, the room is fully operational and held its first Township Board meeting on December 6.



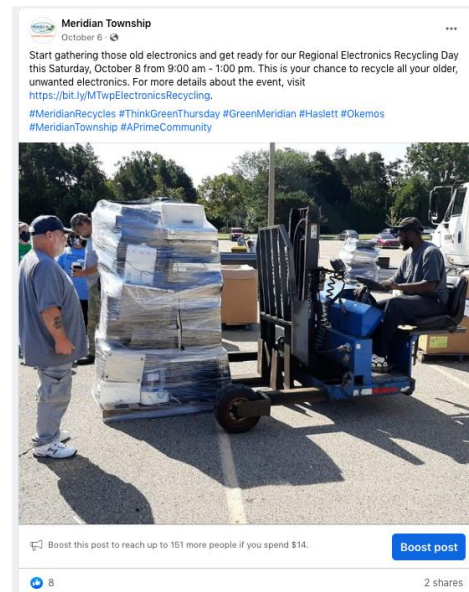
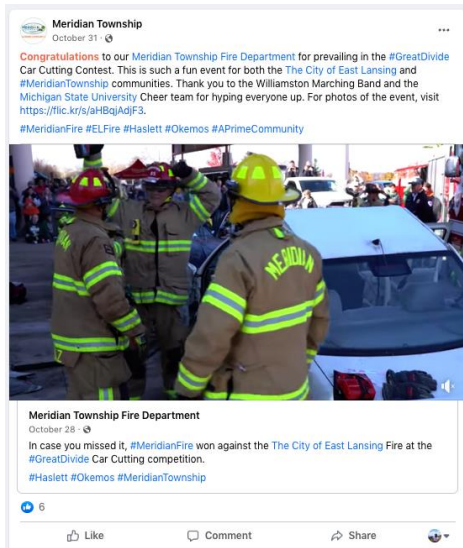
**Marketing & Communication**

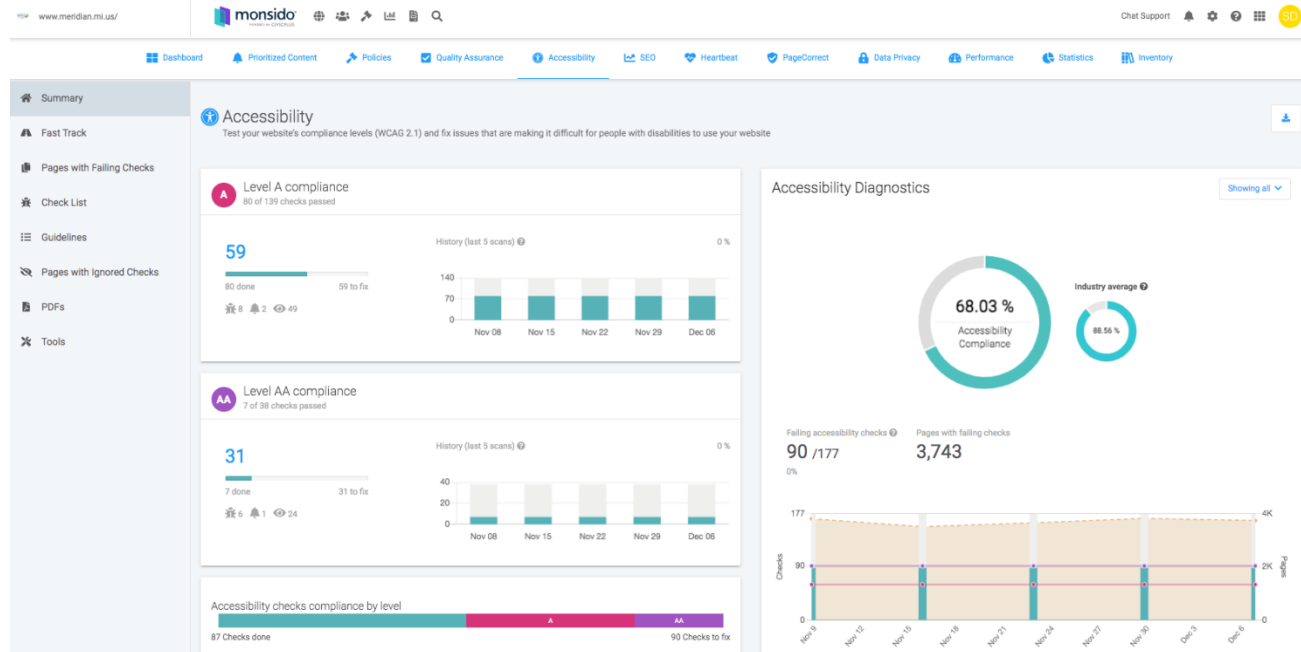
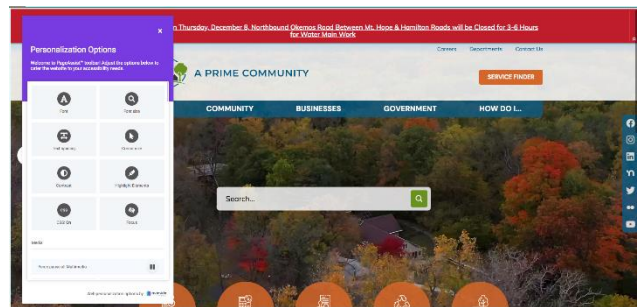

### Meridian Township Website Accessibility

In September 2022, Staff began a partnership with Monsido, a company who specializes in providing website accessibility services for users of the website and those who manage the website. Monsido runs a daily scan of the Meridian Township website and lists issues that are not compliant with Web Content Accessibility Guidelines (WCAG) 2.1 levels. On the backend, Manager Diehl is able to see what issues arise and fix them. This leads to an increased accessibility level. When a user visits the Meridian Township website, they will see a small, purple icon in the bottom left-hand corner of every page. Selecting the icon allows the user to change font style, font size, text spacing, cursor size, contrast and more. Manager Diehl has attended one webinar on website accessibility and will continue to learn more in 2023. Right now, the website is at 68% accessibility compliance, when the industry standard is 88%.

**HOMTV Programming & Internship**

HOMTV's Your Choice 2022 Election coverage returned for the November General Election. Staff conducted 9 total candidate interviews across six races. This was the first time since 2018 that candidate interviews could be conducted in the HOMTV studio. Interviews were conducted by intern Sydney Kuenzer, intern Mackenize Dekker, and Manager Diehl.

This year, HOMTV approached election night coverage differently. Due to the increase in absentee voters and results not coming in until later, Staff decided to try a two-part series. On Tuesday, November 8, a pre-result show aired at 8:00 pm on HOMTV's channel and social media platforms. Multimedia Specialist McDole and intern Mackenize Dekker hosted the pre-show where they discussed the races and ballot proposal results that would be covered in the result recap show on Thursday, November 10.

The result recap show aired at 8:00 pm on Thursday, November 10. Multimedia Specialist McDole and Mackenize Dekker also hosted this segment. They went over the results from multiple races impacting Meridian Township and the state of Michigan. Clerk Deborah Guthrie was also featured in this episode to talk about how the election went.

HOMTV launched a new show titled 'Catching Up with Kenize' on Friday, December 2. This show is hosted by intern Mackenize Dekker and is aimed to be lifestyle segment that shows off different attractions in Meridian Township. The first episode was filmed at High Caliber Karting and Entertainment. The second episode will air on Friday, December 16 and will showcase the Christmas in the Village event at the Meridian Historical Village. Since the internship ends that day, the show will go on hiatus until 2023. Mackenize will be returning in the spring semester to continue hosting the show.



The fall 2022 semester of the HOMTV Internship Program consisted of three interns and former intern Courtland Jenkins. For the spring 2023 semester, there will be two new interns and two returning interns.

**2023 Communications Department Goals**

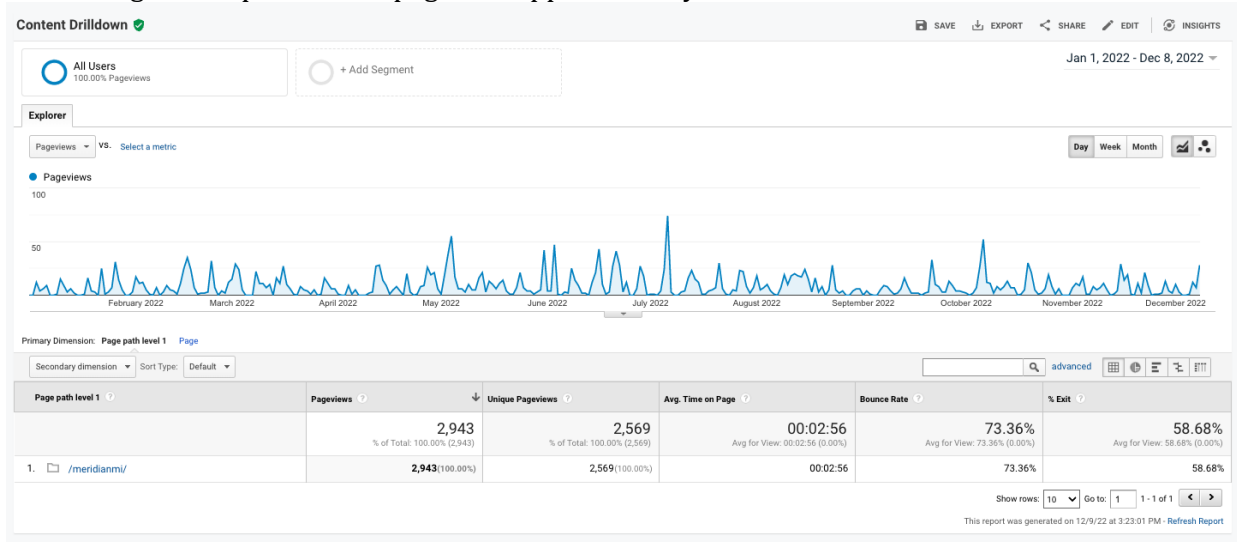

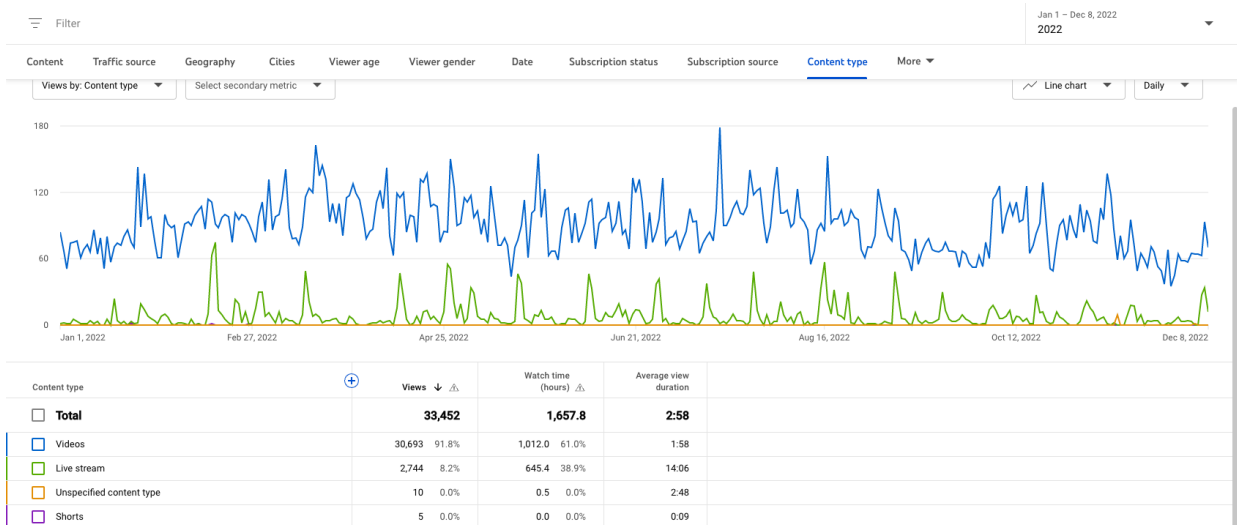
**HOMTV Website Video On-Demand (Swagit)**

**YouTube Live vs. Uploaded Content Stats**

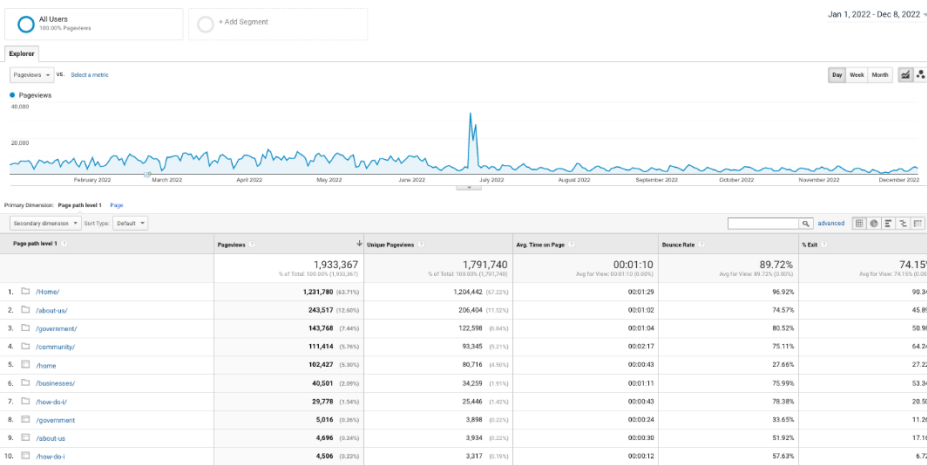

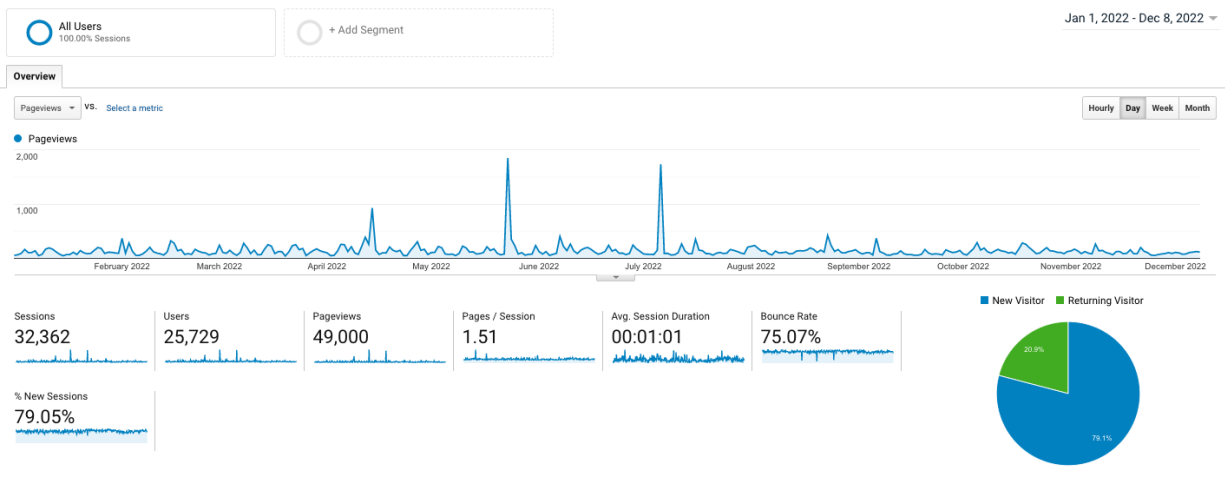

## Updates

I recently attended a Social Media Strategies Virtual Summit. The Summit was two days filled with content, best practices, and quick tips to assist with all aspects of communications, marketing, and social media for government entities.

I will be working with Harris Nature Center staff providing training on the use of our social media scheduling software, as well as quick tips and tricks for using Canva Teams, graphics software. Additional training will also be done with the Parks and Recreation staff to assist with meeting Township Brand Standards.

I have been working with the Assistant Township Manager on new internal building signage, creating new designs and collecting quotes from two separate sign companies. These new sign designs include the Township brand colors and brand elements.

## Paid Ads on Social

We continue to boost posts and use paid advertising on our social platforms to reach more members of the community. Due to the change in settings by most social platforms, we discovered that organic posts are not being seen and important information is not reaching community members in a timely manner.

I am excited to announce that the Nextdoor platform now has an ad option that can be used for recruitment, as well as other promotions. Our Nextdoor agency account has the most followers of all our social platforms.

## New Accounts

Recently, we added an Instagram account for our Parks and Recreation department. We are hoping to expand engagement and reach with this built-in audience through video and stories on this platform.

## Facebook

**Meridian Township:** Total Facebook followers YTD is 8,352, which is an increase of 126 new followers. Total Facebook page reach from September 24 – December 8 was 74,913, which is an increase of 17.1%. Page visits equaled 8,702, which was an increase of 7.8%.

**HOMTV:** Total Facebook followers YTD is 2,426, which is an increase of 13. Total Facebook page reach from September 24 – December 8 was 8,416, which is an increase of 205.7%. Page visits were 1,539, which was an increase of 207.2%.

**Meridian Township Parks & Recreation:** Total Facebook followers YTD is 2,978, an increase of 62 new followers. Total Facebook page reach from September 24 – December 8 was 18,005, which is an increase of 9.1%. Page visits were 1,487, which was a decrease of 37.3%.

**Harris Nature Center:** Total Facebook followers YTD is 3,776, which is an increase of 80. Total Facebook page reach from September 24 – December 8 was 22,393, which is an increase of 40.8%. Page visits were 439 which was a decrease of 29.9%.

**Meridian Township Farmers' Market:** Total Facebook likes YTD is 11,073, which is an increase of 250. Total Facebook page reach from September 24 – December 8 was 842,035, which is an increase of 170.8%. Page visits were 4,335, which was a decrease of 54.9%.

**Meridian Township Fire Department:** Total Facebook likes YTD is 2,511, which is an increase of 16. Total Facebook page reach from September 24 – December 8 was 11,922, which is a decrease of 75.7%. Page visits were 595, which was a decrease of 35.8%.

## Twitter

**Meridian Township:** The communications staff is in a wait and see mode about the Twitter platform due to new ownership and recent announcements pertaining to the platform. It may not be the most trustworthy platform for government moving forward.

Total followers YTD are at 3,276, which is a decrease of 28 since the 3<sup>rd</sup> quarter. Many individuals are leaving the Twitter platform due to recent announcements about the platform. Twitter impressions from September 24 – December 8 equaled 18027 with 2,948 profile visits. The top tweet, which earned 1,200 impressions during the period, was about the Meridian Happenings newsletter talking about the Bonus Bucks program, new Water & Sewer rates, Meridian Cares Fundraisers and more. The top mention, earning 20 engagements, was a tweet from @MichiganEGLE about the Electronics Recycling Event results. The top media tweet, which earned 408 impressions, was about @RideCATA getting people to the polls to vote with free rides.

**HOMTV:** Total followers YTD are at 1,747, a decrease of 18. Twitter impressions from September 24 – December 8 equaled 4,323 with 733 profile visits. The top tweet, which earned 287 impressions during the period, was announcing Election Day in November. The top mention, earning 10 engagements, was a tweet from @ChadMGuerrant talking about his candidate interview for the election. The top media tweet, which earned 101 impressions, was about @polsdofer's interview running for 14<sup>th</sup> District Ingham County Board of Commissioners.

### Instagram

**Meridian Township:** Total Instagram followers for Meridian Township YTD equals 2052, an increase of approximately 1.8% over the 3rd quarter. Profile visits equaled 486, which was a decrease of 10.2%. Posts reached 3,085 accounts, which was an increase of 16.8% compared to 3<sup>rd</sup> quarter. Post interactions equaled 1,165, which was an increase of 6.2% compared to 3<sup>rd</sup> quarter. Content interactions equaled 1,340, an increase of 9.2% and accounts engaged equaled 371, which includes an increase of 165% more accounts that weren't following when compared to the 3<sup>rd</sup> quarter.

**HOMTV:** Total Instagram followers for HOMTV YTD equals 494, an increase of 16. Posts reached 1,171 accounts, which is an increase of 586% when compared to 3<sup>rd</sup> quarter. Post interactions equaled 158, an increase of 3,060% when compared to 3<sup>rd</sup> quarter. Content interactions equaled 266, an increase of 1,230% when compared to 3<sup>rd</sup> quarter. Accounts engaged equaled 84, an increase of 600%.

As you can see, our engagement and reach increase substantially with a new group of interns and dedicated social media & promotions team. We need to find a way to keep the accounts active in between semesters.

**Harris Nature Center:** Total Instagram followers YTD equals 833, an increase of 51. Posts reached 2,648 accounts, an increase of 240%. Post interactions equaled 203, a decrease of 41.9%. Content interactions equaled 323, a decrease of 18.9% when compared to 3<sup>rd</sup> quarter. Accounts engaged equaled 134, which included an increase of 341% more accounts that weren't following.

**Meridian Township Farmers' Market:** Total Instagram followers YTD equals 1,203, a decrease of 53.8%. Posts reached 1,117 accounts, an increase of 8.8%. Post interactions equaled 685, an increase of 20.5% when compared to 3<sup>rd</sup> quarter. Accounts engaged equaled 158, a decrease of 9.2%.

### LinkedIn

**Meridian Township:** Total LinkedIn followers are up to 707. Post impressions is at 2.6K, which is an increase of 2.6%. The account also had 34 unique visitors.

**HOMTV:** HOMTV LinkedIn has 1,224 followers. Total impressions equaled 1K, with 14 unique visitors and 2 new followers.

**NextDoor** – Nextdoor continues to be the best method of communicating various information to the community.

Total members equal 12,385, an increase of 132 new members since September 23, 2022.

**Constant Contact** – The Communications Team sends out a weekly eNewsletter, Meridian Happenings and assists with the monthly eNewsletter, the Green Gazette created by the Green Meridian team. Recently, we started using our Constant Contact lists to send out urgent messages and special editions of our Meridian Happenings newsletter, which is either a shortened newsletter or a postcard style with just one message.

Currently, we have 9,543 contacts with an average open rate of 47% and click rate of 14%, which are all above the industry average by 10%. This percent remains high because the newsletter is shared on our social platforms and sent to contacts that have stated they want to receive information about the Township. The newsletter is our second best means of communicating information to residents.
