 - a. A variety of native pollinator plants will be installed as a seedbank garden on May 22, 2021.

 - c. Interpretive signage for the wildlife viewing overlook, native seedbank garden, prairie benefits, and prescribed burn benefits



There is a parcel of land in Haslett that I wish you would consider purchasing. It is about 6 acres and is on the south side of the railroad between Carlton St. and the crossing on Haslett Road.

This parcel has some historical significance for those who can recall the earlier days of Haslett.

In August of 2005 the Town Courier had an article telling of the development of Haslett and the coming of the railroad in 1879-80. This railroad was a depot for farmers to ship grain and livestock. The livestock pens were on this 6 acres. In "The History of Haslett-Lake-Lansing" book on pages 60 you can see a photo of the livestock pens, and on page 59 the fourth paragraph tell of the stock yards and who operated them.

Our brother-in-law, the late Orton Honeywell, related to us that as a boy living on Haslett Rd., when the horse herds were driven down the street to the pens, he would run out and grab a horse's mane and get up and ride the horse to the stock yards.

The side track for the cattle cars was on this side of the track. The water tower to fill the steam engines was also situated on this same parcel of land. You can see a picture of this water tower on page 15 of "Turning Back the Pages".

There is another reason for preserving this land. There are several deer who come there browsing in the field, and eating the apples in our orchard in the fall. They bed-down in the woods, there. We have seen a doe and her fawn and two yearlings this past summer. They are back there this winter, too. There are also a lot of rabbits, squirrels, ground hogs, and occasionally an opossum The birds also abound there with cardinals in the pine trees and other birds including a snow owl who shows up occasionally

There is a small stream which parallels the railroad on the east end which runs through the culvert under Carlton Street into the pond beyond. The carp from Lake Lansing come through the culvert under the RR tracks and traverse this stream to the pond to spawn. At one time that stream was filled in, and the DNR made the owner reopen it for the carp.

I trust that you would consider this small parcel of land for both the history of Haslett, and for the deer and other animals and fish who use it now.

As requested by Mr. Potter I am giving you some history of the property adjoining the rail road tracks between Haslett road and Carlton Street.

This property was purchased from the Haslett Elevator in 1951 and incorporated as Haslett Feed and Grain, Inc by my father Nelson Sheldon in 1953 or 1954. We had a fire and the elevator was destroyed, we then decided to discontinue the elevator business in favor of a lumber yard.

We have never used any harsh chemicals in the lumber or elevator business. This was strictly a retail lumber yard. During the years we have purchased land all the way through to Carlton Street. Some of this land was low and we did some fill close to the Carlton Street. All of this soil was received from local builders needing a place close by to dump the dirt from new home construction. To the best of my knowledge this soil was clean.

Prior to being the lumber yard the front half of this property was used as an elevator. The back portion which Mr. Potter owns was vacant property. If you have any questions or concerns regarding this matter please feel free to contact me at my office number (517) 627-5362.



It is my understanding that the Board has been looking into acquisition of property in Haslett off of Carlton Street and Haslett Road. I feel this property is an ideal candidate for the Township to acquire. The property directly drains into Lake Lansing and Township ownership would help protect the lake and watershed. I have resided on Carlton Street since 1978 and observed that property closely since then. The "original" owner of the property since the 1920's, Don Carlton now deceased related the oral history of the property to me. I would like to assure the Board that to my knowledge there has been no environmental concerns caused by previous usage of the property. At one time topsoil was removed from the site by a failed attempt to build a lumberyard showroom. Following this fill was brought onto part of the site. I observed this fill at the time and it consisted of dirt and concrete with a small amount of asphalt. My observations at the time were intense as other residents and myself were in constant contact with the Township to ensure this property was in compliance with wetland fill regulations. If the Township keeps records of this you should be able to find that it was inspected at that time. The only other "fill" on this site happened after a train derailment, which spilled clean silica sand, which everyone in the neighborhood used for sandboxes. Currently the land has some wooded area and open field with a variety of wildlife.

I would be glad to answer any questions you may have regarding this site. Good luck in your decision process.

Lake Lansing Advisory Committee Memorandum

A description of the parcel in question is attached.

To: Meridian Township Land Preservation Committee

Re: Property under consideration

At your February 12th meeting you asked the Lake Lansing Advisory Committee to provide you an opinion regrading a parcel that is under consideration by the Land Preservation Committee.

We have met and discussed the parcel and a few of us visited the site and walked around it. The following is our opinion:

First we think this site has high ecological and natural function values in regards to Lake Lansing.

* This site appears to abut a drain that drains under the railroad tracks and under Lake Drive, then directly into Lake Lansing.

* Because of the hill, or ridge at the south end of the parcel along Haslett Rd., as well as the size and configuration of the site, adjacent properties appear to drain through this site as well.

* Currently, there appears to be a few wetland type plants along the North edge of this site, (or perhaps on the Railroad right of way) that act as a buffer to filter runoff water prior to entering the drain.

* This site also doesn't appear to contain any buildings. So, it is currently 100% permeable surfaces, which also aids in the filtering of runoff.

* There was some evidence uncovered during the creation of the Lake Lansing Watershed Management Report that the wetlands adjacent to Lake Lansing in the immediate vicinity of this drain are spawning grounds for pike.

Second, we think that given the fact that this parcel is zoned "commercial" there is considerable risk of losing these beneficial natural features. Given the 5+ acre size and the frontages on both Haslett Rd. and Carlton, this property could easily end up as one big parking lot.

Thirdly, if the Land Preservation Committee were to purchase this property, there would be considerable interest from the Lake Lansing Advisory Committee and the LLPOA in helping to improve its features to make them even more beneficial to the Lake.

We strongly encourage you to pursue purchasing this parcel for the above reasons.

RE: Pike Migration in Channel North of Potter Property

The Land Preservation Advisory Board raised the question: Is the channel north of the Potter property significant in any way with respect to the movement of northern pike to the large wetland located east of Carleton?

I contacted Dr. William Taylor, chair of the Department of Fisheries and Wildlife at MSU, about this question. He referred me to Dr. Dan Hayes, a faculty member who is a resident of Meridian Township, is a fishery expert, and is very familiar with Lake Lansing and this particular site.

Dr. Hayes investigated the site on 12/5/04. He determined that the channel is in fact a viable access route for northern pike to the marsh east of Carleton. He also observed that the wetland size and other characteristics make that wetland an outstanding spawning area for pike and other fish species.

<u>RECOMMENDATION</u>: Dr. Hayes believes that the most important actions that can be taken to preserve the value of this area for pike spawning (made especially valuable by virtue of the fact that Lake Lansing is critically short of such areas due to residential development and filling of wetlands around the lake) would be to:

- 1) Enhance the channel by removing discarded railroad ties and other trash,
- 2) Prevent blockage and ideally increase the size of culverts under Lake Drive, the GT tracks and Carleton,
- 3) Prevent encroachment and degradation of the large wetland east of Carleton and,
- 4) Require strict stipulations designed to prevent adverse impacts on the pike channel if or when the Potter parcel is considered for development.

The upshot of this evaluation is that purchase of the Potter property by the Township would not be necessary to protect this pike channel because the parcel, in its present condition, does not significantly improve or protect the value of the channel for pike migration. There are, however, other actions that can be taken to protect the integrity of pike spawning in this area. The DNR, for example, might be in a position to assist with channel improvement if Meridian Township were to ask for such assistance. And, the LPAB may wish to take a harder look at the possibility of acquiring the wetlands east of Carleton.

Dear Land Preserve Neighbor:

Meridian Charter Township has acquired the land located behind your rear property boundary. This property is designated as a "Land Preservation" area. The mission of the Land Preservation Program is to protect, preserve, and enhance Meridian Township's open spaces and natural features for the purpose of enhancing and sustaining natural habitat and to leave a valuable natural legacy for future generations.

We are sending this letter to all neighbors of the land preserve as a friendly reminder of some of the activities that are not allowed within the land preserve. The Meridian Charter Township Code of Ordinance, Section 46-2 states that it is not permissible to throw, place, or leave; or permit the throwing, placing or leaving yard waste including, but not limited to, grass clippings, clippings from hedges or shrubs, or detached tree branches within lands within the boundaries of the Township owned properties. Section 22-95 of our Land Preservation Ordinance states that you may not damage, deface, destroy, throw or deposit trash or litter on land preservation property. It also states in Section 22-113 that no installation, construction, or maintenance shall be made above or below ground, across or beneath Land Preservation Property by any person, except duly authorized personnel, or without written permission from the Land Preservation Advisory Board.

If you have placed the items mentioned above in the land preserve, this letter serves as notice that you have 45 days to remove the items stated above from the Township Land Preservation area.

Please join us in our efforts to protect and preserve the Township's open spaces and natural features. We encourage residents who live near Land Preservation parcels to act as volunteer citizen stewards. These stewards help the Township by acting as our eyes and ears for these ecologically sensitive areas. If you would like to learn more about the program, the Land Preservation Advisory Board generally holds their meetings on the second Wednesday of each month. These meetings, which are open to the public, are held virtually over Zoom at 6:00 p.m.

Dear Land Preserve Neighbor:

In addition to the letter you received reminding you of the Township's land preserve ordinance, we would like to outline a plan of action that has been developed in order to improve the natural flora and fauna, as well as the accessibility and aesthetics of the Lake Lansing South Preserve.

Lake Lansing South Preserve Project List 2021-2022:

- **Property Fence:** Installation of a split rail fence that borders the entirety of the Lake Lansing South Preserve property. If you have any personal items stored on land preserve property, you will have 45 days from the date of this letter to remove such items, or they will be removed by the Township.
- Mowing Memorandum Agreement: Once completed, this document will be made available to any neighbors living adjacent to the Lake Lansing South Preserve. Once signed it will allow the property owner to maintain a mowed path of up to 10 feet between the preserve property line and the newly installed split rail fence.
- **Signage:** Installation of the official Land Perseveration Marker sign, as well as signage outlining preserve rules and conduct.
- Native Garden: The addition of a native seedbank garden by the Meridian Conservation Corps. This garden will serve as a source of native seeds to spread in the preserve. The goal is to introduce more native wildflowers that are beneficial to local insects and pollinators, as well as increase the aesthetic value of the area.
- **Invasive Plant Management:** Manage invasive plants by removing priority species currently disrupting the native vegetation in the preserve.
- Tree Protection: Protect existing native trees and shrubs from deer browsing.







Native plants promote biodiversity and require fewer resources such as fertilizers, pesticides, and water than their invasive counterparts.

This seedbank will be used for:



Land Preserve Rules Sign

Enjoyable Activities:

- Hiking and jogging
- Wildlife viewing
- Walking pets on a leash (dispose of pet waste)
- Fishing with a valid state fishing license
- Cross country skiing and snowshoeing
- Photography

Prohibited:

- Dogs off leash or on a leash over 6ft in length
- Failure to remove and properly dispose of pet feces
- Littering and dumping of trash or yard waste
- Picking, cutting, or removing trees, flowers, or other plants*
- Horses, llamas, and other draft animals
- Hunting, trapping, or injuring wildlife*
- Disturbing nests or other wildlife habitation*
- Camping
- Fires*
- Fireworks
- Vehicles*
- Biking, except where permission is given on trailhead
- Use of a firearm or other weapon*
- Flying of model aircraft
- Swimming, boating, skating, sledding
- Club and team activities*
