### Re: Mud Lake Outlet, Old English Estates Branch Drain Maintenance Project

Dear Property Owner:

You are receiving this letter because you own property in Meridian Charter Township in the area where the Mud Lake Outlet, Old English Estates Branch Drain Maintenance will be occurring soon (please see attached map). The project involves reconstruction of a failing storm drain on a portion of Downing Street prior to Meridian Charter Township completing the repaving. Barring any unforeseen delays and weather permitting, the work is scheduled to begin on **Friday, July 7, 2023** and will take approximately two to three weeks to complete.

The portion of Downing Street within the construction zone will be closed daily to through traffic but open to residents who front the maintenance limits and emergency vehicles. Even though the road will be closed to through traffic, accommodation will be made for the several residences along Downing Street that are within the construction zone. Residents of these homes will be able to come and go during the day. Downing Street pavement will be pulverized leaving a gravel-like, but travelable surface during the duration of the drain maintenance. Upon completion of all of the pipe work, the road will be resurfaced.

Although there is no way to avoid the inconvenience attendant with this or any other infrastructure maintenance project, I want you to know that my Office is absolutely committed to doing everything possible to minimize the impact on you and your family's daily lives. Drain Office and other Project staff will be on site during all construction activities should questions or concerns arise, and they will also be available anytime by phone and Internet (see contact information below).

In closing, please know that I consider it a great honor and privilege to serve you and the other citizens of Ingham County. My staff and I work for you, and your satisfaction with the drain maintenance project is of paramount importance to us.
