### 9. OTHER BUSINESS

a. RRC (Redevelopment Ready Communities) Housing Ordinance Introduction

Director Schmitt outline the housing ordinance introduce to the commission.

Commissioner Scales inquired on what the intent of this ordinance would be, and what the expectations are for this ordinance.

Director Schmitt noted there will be a public hearing on August 28<sup>th</sup>, 2023. In September, this will be discussed by the Planning Commission, then the ordinance will be brought back to the Township Board for approval.

Commissioner Brooks inquired on how the review process will go for this ordinance. He further asked if there is a comparable study that was done in East Lansing that we would be taking in account.

Director Schmitt stated that the commission should send all questions to his team and they can have answers by the next meeting. He further stated that surrounding areas will be taken into account, however, Meridian Township has a much different landscape than the surrounding cities or towns.

Commissioner Brooks inquired if there has been thought put into the alteration of housing prices due to this ordinance taking effect.

Director Schmitt noted that this is something they are also looking at other communities to see how they adapted to their ordinance updates related to this.

Commissioner Snyder inquired what the difference between a single-family home with an accessory dwelling unit vs a two-family home.

Director Schmitt noted that his team's recommendation would be that the owner of the property must live in one of the units of a single-family with an accessory dwelling unit. Additionally, the design of the structure would be such that it looked like a single-family home, not a duplex.

Temporary Chair Shrewsbury spoke on the validity of short-term vs long-term rentals in this ordinance, if any are allowed at all. She inquired if this ordinance would affect the Master Plan.

Director Schmitt stated that yes, this would affect the Master Plan.

Temporary Chair Shrewsbury inquired if the existing setbacks are required, would any properties in the township be eligible for a stand-alone accessory dwelling unit.

Director Schmitt noted that this would be dependent on how the lot is laid out.

### 10. MASTER PLAN UPDATE

a. Director Schmitt outlined the discussions and key points for the Master Plan update.

Commissioner McCurtis inquired on how this plan will be sent to citizens or those who requested it.

Director Schmitt stated that this would be sent out digitally, i.e., email & the township website.

Director Shrewsbury inquired if the team will reach out to neighborhood leads on this as they have for previous projects.

Director Schmitt stated that they will reach out to neighborhood leads.

Commissioner Brooks inquired how he can submit comments if he isn't at the next meeting.

Director Schmitt noted that any commission comments can be sent to his team for review at any time.

Temporary Chair Shrewsbury noted concern with the amount of links in the document.
