A. 2024 Budget Requests-Parks

LuAnn Maisner, Director of Parks and Recreation joined the meeting via telephone at 4:47 pm to participate in discussion of Action Item 2024 Budget Requests – Parks.

MOVED BY COMMISSIONER LICK, SUPPORTED BY COMMISSIONER STEPHENS TO RECOMMEND APPROVAL OF THE 2024 BUDGET REQUEST FOR PARKS AS PRESENTED.

8. PRESENTATION/DISCUSSION ITEMS

A. Michigan State University Targeted Anti-Tick Project – Emma Campbell

We are pleased to announce that Michigan State University will be partnering with Meridian Township conducting research on the deer and tick population utilizing the Deer Management Program. The goal of this research project is to potentially develop a deer-targeted oral drug delivery unit to reduce the environmental risk to humans due to tick-borne diseases, such as Lyme disease. The research with Meridian Township is based solely on gathering information on the deer and tick population and the potential dissemination techniques that could be used for future administration of anti-tick medication. As a result of this collaboration, Meridian Township will benefit from data received, which will provide information on our deer herd numbers as well as the rate of Lyme disease in the Township.

Objectives of the study:

• Quantify questing tick abundance and parasitism of deer.

- Quantify deer and non-target wildlife species use of field sites for potential deployment of oral medication delivery units.
- Quantify consumption rates of a food product designed to deliver medications to white-tailed deer at different times of year.
- Quantify update of a placebo biomarker (rhodamine B) by deer to examine theoretical uptake of medication.
- Communicate project goals and results to Township officials and public.

Michigan State researchers will begin the project in August of 2023, conducting field recon prior to the study to ensure study sites are chosen with little to no public activity. There will be six to eight sites of study total across Township lands. The study will remain in effect until May 2026. Township staff place high value on research collaboration with Michigan State University, and the benefits future studies will provide for the local wildlife, natural areas, and residents of Meridian Township.

Commissioners agreed the tick study is a great opportunity for education and are happy to partner with MSU.

Here is where we stand for the exterior project at HNC:

1. Painting contractor has been selected for painting the brick (majority of the building) a dark gray with blue tones:

Tony Grants Painting: \$4,375.00

2. Siding contractor has been selected for siding with board and batten vertical siding in lighter gray (flagstone) also with blue tones:

Palmer: \$11,280.00

3. Masonry contractor has been selected to do the front entrance and under the front windows with stone that matches the restroom building and pavilion:

5 Star Masonry: \$6,660

This will be roughly \$7,315 over the \$15,000 budget. Nothing is inexpensive anymore unfortunately and our crew does not have time to take this work on. They will be replacing 2 of the windows in house though which will save a little bit.

Can we do a budget amendment OR use money out of another line item? It's possible the paint company won't be able to paint until 2024, but we won't know that until September.

12. OTHER MATTERS AND COMMISSIONERS' COMMENTS

Commissioner Van Antwerp inquired if we can spray the roots at Ted Black Woods. She feels they are dangerous as people run/walk and cause a trip hazard at this park. Emma Campbell states she has had other people request the same. Commissioner Van Antwerp asks if this would be a volunteer task as we are short handed in Parks department and do not have the manpower to accomplish during work hours. She notes that Lake Lansing Parks has the roots marked throughout the trails.

Commissioner Stephens inquired when there is a storm where the debris and fallen trees in the parks and preserves end-up. Is this an opportunity to cut and sell firewood to generate income for township? Could a sawmill be hired for education purposes? Commissioner Van Antwerp states fallen trees create natural habitats for wildlife. Lack of manpower does not make sale of firewood a feasible option. The public is not allowed to enter parks and preserves to cut up trees themselves as this is a liability issue.

Re: Park Sign Project Budget Amendment Request

The replacement of the "Welcome to Meridian" signs along with phase I of our park identification signs have been a great addition to community and supports our community's branding program. A total of fifteen new park signs have been ordered with many installed in 2022 and 2023. This project has been done in conjunction with Public Works with efforts lead by Deputy Manager, Dan Opsommer and Special Projects Director, Melissa Massie. They have worked to secure funding and continue to manage this project administratively.

The reason for this request is that costs for these special signs have a good chance of increasing if this project continues through 2025. A total of \$100,000 has been approved in the 2024 budget which will fund half of the remaining signs. With another \$100,000 allocation for 2024 this entire project can be completed at current pricing and with the same vendor by the end of 2024. Because these signs are specially fabricated, if a new vendor was awarded the contract in future years, differ from what has already been installed. For reasons of increased costs and sign continuity, staff is recommending a 2024 budget amendment request in order to fund and complete the project in 2024. If approved, the signs will be ordered now so fabrication can begin with installation planned for next year.
