**Re:** Election Commission Action Items

The Election Commission is required to approve the establishment of an Absentee Voter Counting Board and appoint Inspectors to serve; establish a Receiving Board and appoint Inspectors to serve; and appoint Precinct Inspectors; all subject to adjustments as necessary.

The Election Commission must also schedule a public accuracy test for the February 27, 2024 Presidential Primary Election. The public accuracy test needs to be scheduled to take place no later than February 12, 2024. I would recommend the test be held on Wednesday, January 31, 2024 at 10:00 am.

Jurisdictions with a population of at least 5,000 will be eligible for pre-processing. Pre-processing is allowed to begin on Monday, February 19th, however we will begin the following Monday, February 26th between the times of 7:00 a.m. to 8:00 p.m.

The following motions should be considered:

"Move to approve the resolutions of establishment of an Absentee Voter Counting Board and the appointment of Inspectors to serve; to establish a Receiving Board and the appointment of Inspectors to serve; and to appoint Precinct Inspectors to serve; and to approve the pre-processing of Absentee Ballots on February 26, 2024; and to appoint inspectors to serve all subject to adjustments as necessary by the Clerk, for the February 27, 2024 Presidential Primary Election"

"Move to Hold the January 31, 2024 Presidential Primary Election Public Accuracy Test on Wednesday, January 31, 2024 at 10:00 am, subject to change via the Clerk."

<b>WHEREAS,</b> MCL 168.679(a) provides the Election Commission of a city, township, or village shall, by resolution, provide that at an election at which the ballots are counted and certified at the precinct, one (1) or more additional boards of election inspectors be appointed to serve as Receiving Boards; and
<b>WHEREAS</b> , the Charter Township of Meridian Receiving Board is responsible for the duties as outlined in Section 168.679(a) of the Michigan Election Law (Article 116 of 1954); and
<b>WHEREAS</b> , the board of election commissioners shall appoint two (2) or more election inspectors, with an equal number from each major political party to the Receiving Board prior to each election;
NOW THEREFORE, BE IT RESOLVED BY THE ELECTION COMMISSION OF THE CHARTER TOWNSHIP OF MERIDIAN, INGHAM COUNTY, MICHIGAN that the Election Commission authorizes the establishment of a Receiving Board and the appointment of two (2) or more election inspectors, with an equal number from each major political party, for all future elections beginning with the February 27, 2023 Presidential Primary Election.
