

#### 1. CALL MEETING TO ORDER

  - A. None.
- 6. DISCUSSION ITEMS
  - A. Stewardship Goals for 2024 Emma do not forget to talk about Floristic surveys, riparian area protections, and leaf litter initiative
    - a. Discussion of the attached 2024 Stewardship Goals and input from board members.
      - i. Board members comments:

- ii. Prescribed burn program: Have staff check to see if we are able to devote any preservation funds to burns on Township parkland (i.e. Legg Park).
  - 1. Stewardship easements could be an alternative option to establish funds for work in these areas.
  - 2. Severe boundaries need to be set in order to make sure funds are only used in those designated areas.
  - 3. Shared funds between parks and land preservation both would have to allocate funds toward prescribed burns, or stewardship in parks.
- iii. Add leaf litter initiative to 2024 goals for both staff and public
  - 1. Come up with a proposal for grounds staff with maps of areas where this is currently an issue; Riverside Cemetery.
  - 2. This initiative works well with the 'No Dumping' ordinance.
    - a. Add educational campaigns and 'no dumping' signs to goals list
- iv. Add individualized management plans for each preserve to 2024 goals
  - 1. Start with priority sites first that receive the most stewardship efforts. This will also include parks that are of high ecological quality and currently stewardship sites (i.e. Legg Park).
    - a. Potentially involve students from Michigan State University; pre-settlement background history for preserves as a foundation for management plans.
- B. Red Cedar River Pledge; reducing the amount of electric scooters in the Red Cedar River/Becoming a good community partner to support this initiative.
  - A. Staff is participating in the community wide Red Cedar River cleanup with Michigan Waterways Stewards, Delta Phi Sigma, and Delta Kappa Epsilon fraternities, this Saturday on November 11 at 10 am.
  - B. Staff will continue to work with Michigan Waterways Stewards on river cleanups and initiatives to improve riparian health around the Red Cedar River.

#### 7. REPORTS

- A. STAFF REPORT: Stewardship Coordinator, Emma Campbell
  - a. Update on current preservation projects & issues
    - i. Cornell-Sweetwood Update
      - 1. Purchase agreement is finalized. Final documentation and negotiation is happening between lawyers and real estate agents before the closing.
    - ii. Preserve rule signage: Signage is set to go up in December when work slows down for the parks maintenance crews.
    - iii. Lake Lansing South Preserve Mowing Policy
      - 1. Mowing from neighbors continues on the preserve
      - 2. Stewardship plans will move forward, managing invasive teasel
      - 3. 1442 Haslett Road parcel delineation is still under legal review
    - iv. Lake Lansing North Burn Update
      - 1. The burn was successful and was hot enough to char logs and burn

most of the leaf litter. About 80% was successfully burned.

- b. Staff leaving in December:
  - LuAnn Maisner (Parks and Recreation Director) and Rebecca Fisher (Assistant Stewardship Coordinator) are leaving at the end of December, 2023. We will miss them both dearly, and we thank them for their hard work at the Township.
- B. ENVIRONMENTAL COMMISSION REPORT: Board Member, Kendra Grassesschi
  - a. Commissioner Grassesschi the last two meetings were cancelled. Please provide any last comments and/or input for the Climate Sustainability Plan. Budget is being finalized for the Green Grant funds. This program has been very successful and is recommended by staff to residents who wish to pursue sustainable initiatives in their community.



#### 2024 Land Preservation Program Goals



#### **Stewardship Objectives & Management Goals**

Implementing land management on an ecosystem level to address the overall environmental health of the Township. Management of priority areas will improve ecosystem health, community health, as well as environmental outreach and education. Program goals are expanding to include homeowner stewardship of nearby wetlands and private property landscaping.

## 1. Invasive Species Identification, Removal, & Monitoring; Continued expansion of contractual management

- a. **Priority species:** a species focus in necessary when setting management priorities. The following species are difficult to eradicate once established, and spread at a fast rate.
  - i. Woody Species: Oriental bittersweet, common/glossy buckthorn, autumn olive, Japanese barberry
  - ii. Herbaceous Species: Japanese knotweed, phragmites, reed canary grass, Japanese hedge parsley,
  - iii. Other species such as honeysuckles, dame's rocket and garlic mustard are managed mostly during MCC workdays in areas of high quality and diverse native plant species present

#### b. Priority contractual management (current & future):

- i. Black locust at Davis Foster Preserve
- ii. Phragmites at Ted Black Woods, Northridge Preserve, Central Meridian Wetlands, and Davis Foster Preserve
  - 1. Additional sites for next year and working on a phragmites outreach program to partner with homeowners for more extensive Township management
  - 2. Japanese & Giant Knotweed treatment at Ponderosa Preserve. Ted Black Woods stands are managed by staff
  - 3. Invasive management at Ted Black Woods; there are a myriad of new & aggressive invasive plant species invading the Grand River side of this park.
- iii. Spot spraying invasive species at preserves (larger tracts of area that need management, but staff has limited time to get to)
  - 1. Tihart Preserve; spot spraying herbaceous and shrubby invasives in the old farm field adjacent to wetlands
  - 2. Red Cedar Glen Preserve; spot spray prescribed burn site

- 3. Spot spray/glove herbaceous and shrubby invasives in the remnant wetland at Davis Foster
- 4. Lake Lansing North Preserve; sweet woodruff treatment (may be done be staff, considering alternatives for this sensitive site)
- c. Preserves currently undergoing active invasive species management include: Red Cedar Glen, Lake Lansing North, Foster-Crouse, Towar Woods, Lake Lansing South, Southwest Meridian Uplands, Serafine, Sower Woods Preserve, Tihart, Tihart-Cornell Wetlands, Forest Grove, Northridge, Ponderosa, Central Meridian Uplands, Sumbal, & Towar Woods.
- d. **Parks currently undergoing active invasive species management:**Nancy Moore, Central Park, Hartrick, Red Cedar Natural Area, Legg, Harris Nature Center, Eastgate, Forest Hills, Ted Black Woods, Hillbrook, Sander Farm, Red Cedar Natural Area, Brattin Woods.

#### 2. Individualized Management Plans for Preserves

- a. Master stewardship and management plans exist for the Township to tackle management issues as a whole, as well as management plans for individualized invasive species
- b. Preserves that receive the most management and have high ecological value will be prioritized first
- c. Once priority preserves are finalized, the rest of the preserves will receive a plan based on the information currently gathered about the area
- d. This process will continue into 2025, and plans will continue to be updated as more information is acquired

#### 3. Expansion of the Prescribed Burn Management Program

- a. Spring of 2024
  - i. Davis Foster Preserve; Unit 1 (see attached burn unit map)
- b. Fall of 2024
  - i. Red Cedar Glen Preserve; 5 acre unit burned in Spring of 2023
  - ii. Legg Park; smaller unit if approved by parks
  - iii. Ted Black Woods Park; smaller unit if approved by parks
- c. Tihart Preserve; consultation from contractor to determine 'burnability' of this site
- d. This goal will also help us reach our goal of Invasive Species Management Township-wide.

#### 4. Land Preservation Boundary Surveys & Marker Replacement

- a. Begin the process of updating boundary markers at all preserves
- b. Currently most preserves lack boundaries due to boundary markers degrading over time
- c. Replace boundary markers at priority preserves, those that receive encroachment from neighbors

#### 5. Planting a Native Meridian Program

- a. Continue expansion of native plant program and habitat restoration at parks, preserves, and private property
- b. Install purchased greenhouse structure for transplant storage, seeding and maintenance throughout the growing season

- i. Great volunteer opportunity, as well as propagation opportunities for small amounts of seed
- c. Continue recruiting volunteers to scout potential seed collection and remnant population sites

#### 6. Michigan State University Collaboration

a. Continue partnerships with MSU Fisheries and Wildlife Department research teams, Fisheries and Wildlife Club prairie restoration and seed exchange, macroinvertebrate and turtle research

#### 7. Meridian Conservation Corps Website Update

a. Update all material and resources on the MCC website, and add updated pictures

#### 8. Update land preservation program brochure and website

- a. Update program brochure and website (work with the Communications Department on this).
- b. Add an educational campaign for no dumping leaves in fall, as well as other yard waste
  - i. Feature on website and post to social media sites

## 9. Continued expansion of educational signage and installment of preserve signage

- a. Preserve Rule Signage: continue installation throughout 2024
- b. Name signage: continue installation throughout 2024
- c. Wetland Education & Restoration signage: ordinance signage ordered and will be installed 2023-24
  - i. Education signage is developed. Order and install in 2024
- d. Trail signage for the following:
  - i. No bikes allowed reminder throughout trails
  - ii. Not a trail, sensitive area signage for ecological diverse areas receiving high traffic
  - iii. No foraging/taking of plant/wildlife reminders throughout the trails
- e. Native plant habitat and restoration signage will be implemented at Township restoration sites, as well as made available to homeowners who are utilizing native plants in their landscaping
- f. No dumping signage at preserves where encroachment is an issue

#### MISSION OF THE PROGRAM

- Protect, preserve, and restore Meridian Township's open spaces and natural features
- Establish a reserve fund for perpetual stewardship of these lands
- Enhance and sustain natural habitat and water quality



- Ensure the continuation of a pleasant and livable community that will benefit our residents, visitors and local economy
- Leave an important natural legacy for future generations

#### **ABOUT THE PROGRAM**

- 950 acres have been preserved to comprise 25 land preserves
- Michigan's first community-funded preserve program
- Designed to permanently protect and restore ecologically valuable natural areas, habitats. and plants
- Recognized by the U.S.
   Environmental Protection Agency as a national model



#### LAND PRESERVATION ADVISORY BOARD

The Meridian Township Board of Trustees appointed an 8-member advisory board to oversee the Land Preservation Program. Duties include:

- Identifying and evaluating candidate properties
- Accepting applications for properties referred by landowners
- Advise the Township Board and Planning Commission
- Aid in development of individual preserve stewardship plans
- Providing public education about the land preserve program
- Ensuring resource availability for continual stewardship activities


### **TYPES OF PROPERTIES**











#### **PROPERTY ACQUISITION PROCESS**

#### **APPLICATION**

Property owner or designee submits application to the Township Clerk for forwarding to the Advisory Board.

#### REVIEW & APPROVAL

The Advisory Board and the Environmental Commission members perform an ecological review of the property. If property is desired, the owner is notified and a real estate appraisal is prepared.

#### **NEGOTATION**

Based upon the appraised value, negotiations for acquisition with the property owner are pursued.

#### **ACCEPTANCE**

If an agreement is met, the Advisory Board recommends acceptance and purchase to the Planning Commission and Township Board.

#### **ACQUISITION**

The Township Board acts upon the recommendation to acquire the property.
