1. CALL MEETING TO ORDER

A: Chair Styka called the meeting to order at 6:01 P.M.

2. CONSENT AGENDA

3. APPROVAL OF MINUTES

4. OLD BUSINESS

A: Fundraisers

6. HUMAN SERVICES REPORT

A: Emergency Funds used in January 2024 were \$2,313.00

B: We received a \$2,500.00 grant from Consumers Energy Foundation. This grant cannot be used for utilities, it can only be used for rent.

- -Specialist Love asked Trustee Wilson if this grant needed to be presented to the Meridian Township board for approval, to which she said no.
- -When the Financial Director puts the grant in the fund it will need to be restricted to rent assistance only.

Commissioner Robinson makes a motion to approve Specialist Love to purchase five \$50 food-only gift cards for distribute as appropriate. Seconded by Commissioner Styka. Motion Carries 5-0.

C: PayPal balance is \$2,625.44

D: In January we purchased another 100 redi-ride passes.

7. BOARD LIASON REPORT

A: Community Center/Incorporating a Senior Center

- Trustee Wilson gave an update on the task force created for the Community Center incorporating a senior center. They have engaged a professional services company that specializes in building municipal buildings like community/senior centers. They are currently identifying needs.
- There is currently a piece of land where a center could be built but they are trying to repurpose an existing building. The task force reached out to the mall to see if Younkers was available. Unfortunately, the building is too large with too issues of high expense.
- Numbers don't make any sense for using the Younkers space.
- If anyone knows of any space around 45,000 square feet, please let the task force know.

B: American House

- American House is a brand-new independent living senior complex.
- They tried to get temporary occupancy, which they were not approved for yet.

C: Other large parcel of land: Haslett Village

- Held up by the Ingham County Drain Office.
- D: Trader Joes will open in early June 2024.
