#### 4. OLD BUSINESS

#### A: Fundraisers

### **6. NEW BUSINESS:**

A: Biggby Coffee Celebration: April 11th

- Options for rounding up your order to support Meridian Cares.
- Specialist Love will inquire about how they decided to choose Meridian Cares.
- Specialist Love will share a photo via email with the Commissioners to spread the word to their network.

B: Protect the Pack: June 12th 5-7 p.m.

- Hosted by Okemos Public Schools
- Supervisor Love attended last year's event.
- They provide the table and chairs and last year we were under a tent.
- Last year we handed out suckers and flyers.
- This year perhaps we will add a kid friendly idea to hand out.
- Specialist Love will check prices of possible handouts.
- Currently this is a CRC meeting night, however we could cancel the meeting and attend the event.

## C: Santa's Helpers

- Santa's First Responders (started by Gayelord Mankowski) have asked Meridian Cares to be part of their holiday party in December 2024.
- This event happens at Murphy Elementary School
- Meridian Cares would provide recipe cards, boxed one pot meals (hamburger helper style), and other food items to be given to the families along with their venison. Doing this helps families know how to prepare and use venison.
- The possibility to use leftover money from the Holiday food needs fund to provide these items or grants or possibly reaching out to Meijer for donations.
- The commissioners are interested in pursuing helping with this event.
- Gaylord said to plan for around 100 families.

#### D: Farmers Market Communication and Outreach

- Tom Cary with the Famers market said that we are always welcome at any farmers market. Just let him know and he will reserve us a spot.
- He is looking at ways to educate the public about how your food stamps can go further at the market.
- At the May meeting, the commissioners will look at the farmers market dates for the summer to plan some possible dates.

### E: Calendar

- A: Emergency Funds used in March 2024 were \$2,976.80
- B: Water bill round ups still is not showing. These should appear in April.
- C: Upon reflection there is an error in one of the numbers either for "starting cash balance" or "ending cash balance". Specialist Love will resend a needs fund report with the correct numbers.
- D: We have used \$250.00 of our \$2,500.00 consumers grant.
- E: We have used \$9,529.63 out of our budgeted \$40,000 for the year.
- F: We thank HOMTV for doing a documentary on Meridian Cares. Thank you, Commissioner Turimella, for sharing in the documentary.
- G: Specialist Love has applied for another TC Energy grant to help with holiday food assistance for 2024.

Affordable Housing:
