North Meridian Road Park Hours

Director Wisinski shared some recent reports of vandalism at the park during night hours. The current protocol is to leave the park open until 11 pm each night for Night Sky Viewing. There was discussion about surveying the community and possibly limiting hours and/or dates to weekends only.

MSU Deer Fawn Study

Director Wisinski discussed the request for MSU Deer Targeted Anti-Tick Project to continue fawn tick research for 2024. Meridian Township Parks and Recreation Department and MSU have a long-standing relationship partnering on this project. The request is an extension of the current project. Commissioner Lick supported the well-thought-out plan. Commissioner Van Antwerp added that the research data will help with future deer management activities. Chair Farris concurred.

8. DIRECTOR'S REPORT

Celebrate Meridian planning is going well. There will be celebrations for the 50th anniversaries of the Farmer's Market and historical Village, music, fireworks, children's play area, food trucks, Marketplace on the Green and Central Park Pavilion beer tents, Nokomis educational activities and Indian, Chinese and Irish dancers are planned.

Renovations to Central Park Pavilion

The roof and bathroom tile begin this week and the soffit, fascia, gutter, ceilings, and lights to be completed next week. We are waiting for approval of engineering plans for the wall and sliding barn doors. The renovation project is anticipated to be completed by the Celebrate Meridian Festival, June 28-29, 2024. The pavilion is closed for the month of May except for the Garden Club Sale.

Red Cedar Waterway Project

Ingham County Parks and Trails Commission and the Board of Commissioners approved Round 8 of grants which allows for Meridian Township to borrow against the match funds allocated with the grant budget.

Cricket

Director Wisinski is working with representatives from the Cricket community to identify a location to install a cricket field. There is difficulty in finding a park largest enough to accommodate the field. Director Wisinski will reach out to Delta Township and Lansing Parks and Recreation to discuss a regional approach. Commissioners shared interest in continuing to find space within Meridian.

Marshal Park play structure will begin excavation Monday April 22, 2024, the structure will be installed the following week, and the turf will be installed 2-3 weeks after structure installation.

Okemos Rd./Gaylord C. Smith Court parcel. Commissioner Van Antwerp requested an update on plans for the parcel and expressed her interest in pursuing a trailhead at the site. Director Wisinski will work with the Department of Engineering to develop a plan for the parcel.







Re: Updates on 5280 Okemos Road Parcel Planning

In accordance with our 2024 Parks and Recreation Goals, the Park Commission is planning for amenities located at 5280 Okemos Road. The Parks Department staff have visited the parcel and is requesting input from the Park Commission on what development would be most beneficial for the residents. With input from the Park Commission and residents the Parks Department staff recommend the development of a trailhead at the site. The 80 mile pathway system connects to the parcel. The parcel amenities could include:

- Restrooms
- Shaded seating
- Water station
- Bike rack
- Parking lot

Staff is recommending proceeding with securing a landscape architect to assess the site for development.

Re: Meridian Cricket Field Discussion

The Parks and Recreation Department Director was approached by residents that are involved with cricket leagues in Michigan and historically have been playing on the east and west side of the state. Until the installation of a cricket field in Delta Township in 2023, the league has not had a field in mid-Michigan.

Cricket has been expanding significantly over the past several years and many of our Meridian residents are Cricket players. Given the increasing interest in Cricket for Meridian residents, developing a local Cricket field is essential and would serve our residents with the resources to play the sport.

Currently, Department staff is researching a park location to install a cricket field. The field requires a large area to install. The Parks and Recreation Department Director has reached out to Delta Township and the City of Lansing Parks and Recreation Department Directors, as well as Okemos Public Schools to approach a potential regional coordination for both practice and games.

Staff is recommending proceeding with pursuing a permanent Cricket field in Meridian Township.
