Exciting to see momentum building at Snell Towar Rec Center programming. Commissioner Stephens suggests more posts on social media regarding Snell Towar programs. These posts and marketing efforts should be shared with the entire township, not just the Towar Gardens neighborhood residents. After reviewing Stewardship items, Commissioner Stephens added that Emma Campbell, Land Stewardship Coordinator, is efficient, cheerful and very informative.

7. DISCUSSION ITEMS

A. 5280 Okemos Road Parcel Planning

In accordance with the 2024 Parks and Recreation goals, Park Commissioners discussed potential uses of parcel at 5280 Okemos Road. Potential trail head, utilization as new entrance in to Nancy Moore Park, potential bike fix-it station with some type of seating and water source, additional parking area all discussed. Commissioners are interested in what landscape architects and engineers propose for the parcel. Commissioner Van Antwerp proposes a red light for pedestrians to safely cross from the MSU to Lake Lansing trail head across Okemos Road.

Commissioner McDonald moved **FOR STAFF TO PROCEED WITH SECURING A LANDSCAPE ARCHITECT TO ASSESS THE SITE FOR DEVELOPMENT.** Seconded by Commissioner Van Antwerp.

VOICE VOTE: Motion carried unanimously.

B. Cricket Program

Director Wisinski is working with representatives from the Cricket community to identify a location to install a cricket field. There is difficulty in finding a park large enough to accommodate the field.

Commissioners unanimously agreed to proceed with pursuing a permanent Cricket field in Meridian Township.

C. Additional Parking at Hillbrook Park

Director Wisinski explains the lack of parking at Hillbrook Park is a continuing issue and visitors are parking on the grass and creating ruts. The parking on grass is also disrupting the park mowing schedule and also the mosquito application schedule. The grass area is extremely wet and visitors get their feet soaked when attempting to park on the street and walk across the grass to get to courts, etc. Estimation of 40 cars need daily parking at the park, and we currently only have 16 parking spaces. Director Wisinski is looking in to a long term solution for additional parking. She will talk to Facilities. In the interim, she will also look in to the pathway suggestion leading from Montebello Avenue to the park to help with the water issue.
