#### 1. Call Meeting to Order

Chair Wilson called the meeting to order at 6:06 pm.

#### 2. Approval of Agenda

Hearing no objections, Chair Wilson accepted the agenda as amended.

#### 3. 2015 Budget and Capital Improvements Program

Director Maisner distributed draft budget information for both Park Millage and General Fund with a list of proposed projects for 2015. She also distributed the 2014-2019 CIP.

She stated these documents illustrate how the revenues have gone down in the last three (3) years primarily due to lower property values. For the next meeting, the Commissioners asked to have the projected SEV for 2014 and 2015. Director Maisner stated currently the expenditures are primarily staff salaries and benefits with not much left for capital improvements or large maintenance items. She suggested a special meeting be called to discuss the proposed 2015 budget and 2015-2020 Capital Improvements Program projects. When the CIP projects are prioritized, this information will be used to develop the 2015 proposed budget.

#### Park Millage Update

Director Maisner distributed an email from Dawn Parker asking for responses to four (4) questions for an upcoming Towne Courier article in advance of the August 5 election. After a brief discussion, Chair Wilson agreed to contact Ms. Parker to obtain more information about the article and communicate with Commissioners. He also asked Commissioners to forward their answers to him.

Director Maisner reported she had a communication from Communications Director Guthrie about hosting an interview show with the Park Commissioners regarding the upcoming Millage. She will forward the email to the Commissioners and asked them to communicate directly with Director Guthrie. Director Maisner reported the next Leadership Breakfast is Thursday, July 10 and the main topic will be the Park Millage. She asked which Park Commissioners would be able to attend. Without looking at calendar, it was indicated that none of the Commissioners present could attend. Director Maisner stated she will call new Park Commissioner McDonald to see if he is available.

Commissioner Banas asked Commissioners to send in more information to post to the Facebook page. She would like to set up items into the future so that something is posted every day or so.

Commissioners discussed the tree surfing component, use of wood for the bridge; the water feature; how the tree house will connect to all the elements; how this project can be phased in and the design is somewhat flexible. #### 1. Call Meeting to Order

Chair Wilson called the regular meeting to order at 7:15 pm.

#### 2. Approval of Agenda

COMMISSIONER STEPHENS MOVED, COMMISSIONER JARAMILLO SECONDED, TO APPROVE THE AGENDA AS AMENDED. Voice vote. Motion passed.

#### 3. Public Comment

Gail Deschaine, 1383 Silverwood Drive, Okemos, spoke in support of the Park Millage and stated a community is only as vibrant and desirable as its public spaces. She and her family love the parks with its many trails, picnic areas and facilities. Parks are a place for the community to meet and enjoy nature and serves as an asset to our community that needs to be maintained. She encouraged everyone to continue this investment in our community.

#### 4. Presentations

- Eagle Scout Project Final Report Legg Park Footbridge Reinforcement Eagle Scout Candidate Thomas Laub distributed and summarized how he completed his project to reset one of the bridges in Legg Park including a new support system to allow water to flow over and/or under the bridge during high water. He installed five (5) U-channels; two more than was on the bridge before. He also squared up the ends of the bridge and filled in the gaps for easier entry onto the bridge. Commissioners congratulated Thomas on his project. When asked about project funding, Candidate Laub reported the concrete was donated by Schlegel Concrete, U-channels were donated by park neighbor Frank Hatfield and the remaining costs were covered by fundraising and/or donations.
- Harris Nature Center (HNC) Nature Exploration Area
   HNC Coordinator Rich offered the following update:
   The Exploration Area will be a multi-phased project

- Phase I consists of basic infrastructure (pathway, fencing, etc.); construction of a sand area/fossil dig; logs of various sizes, lengths and directions for climbing; a "sticks and stones" area for kids to play and build; and an outdoor classroom with a small stage to combine nature with the arts.
- ➤ They are currently working with Impression 5 on the archeological dig element. There will be items of varying sizes including a mammoth tusk, molars, and other small fossils. They are very excited about the educational component for this area with all the cultural history and how it is to be layered.
- For funding, the Foundation applied and received two grants; a \$5,000 grant from the Dart Foundation and a \$5,000 grant from Jackson National Life. The Foundation is raffling off three (3) bikes from Velocipede Peddler with tickets on sale until the annual Turtle Toast when the winning tickets will be drawn
- > Plans are underway for the annual Turtle Toast which will include wine tasting and a silent auction. Information to be sent out in two weeks
- Commissioner Stephens suggested applying to MSUFCU for a grant. He will forward the contact information to the Nature Center.
- > Director Maisner reported the large number of volunteers, grant funding and sweat equity that is moving this project forward.
- Suggestion was made to contact a chain saw artist to carve out the seating area such as the Wood Carvers Association

HNC Coordinator Rich reported on the HNC activities as follows:

- the attendance numbers for summer camps have been steady
- Howl at the Moon is in its tenth year
- Stewardship Mornings are well attended with regulars and some new attendees; for the last two months, they have been pulling Garlic Mustard and will be pulling Japanese Hedge Parsley next
- There have been two work days on the Nature Exploration Area with nine volunteers on each date
- Looking forward to opening of the Van Atta Road bridge; there is a beautiful walkway with a nice slope to the path that connects to Legg Park; special thanks to the Ingham County Road Department and their staff for keeping the

Center staff informed on the progress of the bridge and for construction of the new dock

 Looking for an Eagle Scout Candidate to complete the access connection from the HNC driveway to the new dock

Director Maisner distributed the Department's June monthly report and summarized the following:

- She will be before the Zoning Board of Appeals seeking variances needed to construct an accessible pathway in Wonch Park; the pathway is possible through the award of a grant from the Michigan Department of Natural Resources; the Township has received approval from the Department of Environmental Quality.
- The proposed 2015 Budget and Capital Improvements Program projects are due in July
- The Farmers Market is open Wednesdays and Saturdays, from 8 am to 2 pm until the end of October
- Music in the Park is hosted by the Friends of Historic Meridian on Wednesday evenings in the Historical Village until the end of July
- Have received positive comments and feedback on the fireworks display on July 4<sup>th</sup>; the display was approximately 15 minutes at a cost of \$19,000 with over 15,000 in attendance.
- Steve Brunner and volunteers from the Michigan Mountain Biking Association will be making improvements to the Eastgate Park pump track; the material is from the Cornell Road project
- Special thanks to the Ingham County Road Department for the improvements to the Legg Park entry drive as part of the Van Atta Road bridge improvement project
- Staff will be hosting a dedication of the Eleanor Luecke Memorial and rededication of the Claire Twohy Memorial Garden on July 22 at noon to thank the Meridian Garden Club for adopting garden maintenance and to have a ribbon cutting of the Eleanor Luecke Memorial;
- Parks and Grounds Maintenance Lead Worker Scott Stillman announced his retirement. He has been with the Township over 35 years and has been a great leader for the staff. His knowledge of the parks and strong work ethic will be missed.
- Special thanks to Towar Community Concerns Committee for applying for and receiving a grant of \$6,000 from the Capital Region Community Foundation for the Summer Playground Program at the Snell-Towar Recreation Center. the attendees are also receiving free lunch daily from the federally funded program through Lansing Public Schools.

#### a. Park Millage Ballot Proposal

The following information was offered by Commissioners and Staff:

- the proposed new Park Millage will be on the August 5 ballot and will support the park system, maintenance, improvements and Harris Nature Center.
- the park system has approximately 900 acres but only 200 are developed
- under the current millage, the majority of the funds are absolved by staff salaries and benefits thereby leaving a small amount for maintenance and improvements
- for the last thirty years, the parks have been funded by 1/3 mill and the Commission and staff work very hard to keep the parks from degrading but in order to continue, the new millage is required
- currently 1/3 of the Park Millage budget is taken up by the operation of the Harris Nature Center and without the new millage, that operation may be impacted.
- The Township works with the Friends of Historic Meridian to keep the Meridian Historical Village operational but the safety of the buildings are the Township's responsibility and funds are needed for their upkeep
- the last ten years have been spent on planning for park projects such as Wonch Park improvements, Towner Road Park development, etc.
- Inflation costs have continued to go up, but the park millage has continued to go down
- We have a great volunteer network, staff and facilities but we need to keep the ball rolling and while this new millage will not solve all the needs, it will fund necessary improvements and overdue upgrades to the parks.
- We need to invest in our parks because they are an extension of our own back yards and schools who use these areas for learning and recreational opportunities and activities.
- This new millage will allow for a wider variety of grant application opportunities; funding is needed for grant match and the larger the match, the more favorable the grant application is viewed

Chair Wilson stated the following two agenda items will be discussed simultaneously since the CIP projects are needed to approve a budget. The discussion will include the possibility of a budget if the proposed Millage is passed or not passed.

### 5. Proposed 2015 Park Millage Budget-Capital Improvements Program (CIP) 2015-2020

Director Maisner summarized how budgets for parks are divided. Parks owned by the Township prior to 1984 are paid for by the General Fund. All parks acquired in 1984 and after are funded by the Park Millage. If the Park Millage ballot proposal passes in August, the General Fund will continue to fund maintenance but the Park Millage will fund park renovation and development of all the Township's parks.

Director Maisner explained information that was included in the meeting packet including a draft 2015-2020 CIP and the 2015 budget request for discussion. The proposed budget was prepared to reflect the millage passing. If the millage is defeated, the projects planned in the Park Development budget would be eliminated as well as the full-time utility worker position. Capital projects listed in the Park Development budget are reflected in year 2015 in the CIP.

Park Millage Budgets include: Parks and Recreation Administration; Park Maintenance: Park Development and Harris Nature Center.

General Fund Budgets include: Park Commission; Parks and Recreation Administration; Park Maintenance.



Support of Wildlife Habitat Grant Application for Legg Park

Michigan Department of Natural Resources, Wildlife Division



We feel that this is an ideal source of funding to help develop the wildlife corridors and habitat improvement plans that have been planned for Legg Park. Plans include enhancing "edges" and corridors to facilitate nesting, roosting, and feeding of wildlife in the park. Applicants must commit to provide at least 10 percent of the total project cost.

The Wildlife Habitat Grant application is due on August 12, 2014 and the grants are awarded on October 1, 2014. The specific program goal of the grant is to manage habitat for sustainable wildlife populations in a changing environment. This grant will give us the opportunity to plant mast-producing species such as oak, establishment of a soft mast (crab apples, etc.) to promote winter food sources, and to provide long term herbaceous cover and forage plantings which restore openings that are degraded due to brush and undesirable herbaceous encroachment.

#### Motion for your consideration:

MOVE TO DEDICATE \$5,000.00 OF THE PARK MILLAGE FUNDS AS A 10% MATCH FOR AN OVERALL PROJECT COST OF \$50,000 TOWARD A WILDLIFE HABITAT ENHANCEMENT PROJECT FOR LEGG PARK THAT WILL BE FUNDED BY A WILDLIFE HABITAT GRANT THAT IS FACILITATED BY THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES.

2014 Deer Management Program Update and Request for Approval

Per the direction of the Township Board, staff has prepared a 2014 Deer Management Plan. We continue to explore options on how to improve and expand our program.

There are no major changes to the structure of the overall management plan. Highlights of the expanded program will include the following items:

- Pursue out of season damage permits from the DNR to extend available harvesting period post archery and firearm seasons.
- Continue to encourage large property owners to participate in the program.
- Continue to work with communications department to improve press releases and township website postings informing the public of managed hunt.
- Offer an alternative method of recording hunter participation and improve communication for efficiency in deer transportation to processor.

### RESOLUTION TO ADOPT 2014 DEER MANAGEMENT PROGRAM

At a regular meeting of the Township Park Commission of the Charter Township of Meridian, Ingham County, Michigan, held at the Meridian Municipal Building, 5151 Marsh Road, Okemos, in said Township on the 12th day of August, 2014, at 6:00 p.m., Local Time,

PRESENT: ABSENT:	
The following resolution was offered by Commissioner	and supported by Commissioner

WHEREAS the Charter Township of Meridian has documented numerous complaints relative to the issue of the over-population of white-tailed deer including: over-grazing of landscape plants, a high number of deer/car collisions, threats to public health, and threats to the ecological health of natural areas; and

WHEREAS a Deer Management Plan has been developed for the purpose of outlining measures for conducting a highly managed, safe and humane managed deer harvest on township-owned properties; and

WHEREAS it is recognized that controlled hunting may help control the overpopulation of white-tailed deer: and

WHEREAS the Charter Township of Meridian has authorized staff to conduct a managed deer harvest on township-owned properties that will occur seven days per week during the regular archery season (October 1, 2014 through January 1, 2015); and

WHEREAS the managed deer harvest will utilize qualified, competent, and experienced volunteer hunters; and

WHEREAS the township-owned properties are not open to unauthorized hunting; and

WHEREAS the Charter Township of Meridian will work with the Michigan Department of Natural Resources to operate under the Deer Management Assistance Program for the purpose of purchasing a large number of antierless deer permits; and

WHEREAS the Charter Township of Meridian's Deer Management Program will comply with all State of Michigan rules and hunting regulations; and

WHEREAS the public will be properly notified of the deer harvest through posted signs on the designated hunting properties, township website postings, press releases in the local newspaper, and letters to owners of properties adjacent to designated hunting properties; and

WHEREAS the majority of the venison from the harvested deer will be distributed to the hungry through local food banks; and

WHEREAS the Charter Township of Meridian has constructed an exclosure within Lake Lansing North Park for the purpose of visually observing areas that are open to deer browsing versus areas that are not, which has indicated a significant level of damage due to over-browsing of the natural vegetation; and

WHEREAS parks and natural areas provide ecological and aesthetic beauty, improve water quality, protect groundwater, prevent flooding, improve the quality of the air we breathe, provide vegetative buffers to development, and produce habitat for wildlife; and

WHEREAS the Charter Township of Meridian recognizes the benefits derived from parks and natural areas and appreciates benefits of local wildlife
