**1. CALL REGULAR MEETING TO ORDER**

Chair McConnell called the meeting to order at 7:03 p.m.

**2. GREEN THEMES PRESENTATION:**

Garry Rowe presented the Water Sampling Study. The recent water sampling study examined local wells and ground water. The study took place in six townships and three municipalities, including Meridian Township, East Lansing, Michigan State University and the City of Lansing. Results of the study, in general, showed a decrease in levels of many chemical elements and heavy metals with an increase in levels of sodium chloride and bacteria. The results are thought to be linked to the shallow bedrock and shale profiles and an increased use of sodium chloride for road maintenance. Based on the study, four recommendations were proposed;

- Promote the routine assessment and testing of existing wells.
- A review of road salting policies.
- A review of water softener testing as a contributing factor to the increase in sodium chloride levels.
- Increase water sample studies to one every ten years.
