# 8. SELECTION OF LAND PRESERVATION REPRESENTATIVE BY THE 2015 CHAIR

Following a brief discussion, Chair McConnell selected Commissioner Kielbaso to be the Land Preservation representative for 2015.

- **b.** Tree Projects: staff summarized the two projects impacting trees along Grand River Avenue the proposed building on the former Northwest Tire site and the proposed retail building on the outlot site at 2002 Grand River in front of the mall.
  - **MOTION** by Commissioner Kielbaso to send the following comments to the Township Board regarding the appeal case at the old Northwest Tire site (SUP #14111). Supported by Commissioner Scherbarth. Approved 7-0.

While the Environmental Commission supports the reuse of brownfield sites, it encourages all efforts be used to preserve as many of the six (6) significant trees on the site as possible by utilizing creative design."
