1. CALL MEETING TO ORDER

Supervisor McGillicuddy called the meeting to order at 6:00 P.M.

2. PLEDGE OF ALLEGIANCE/INTRODUCTIONS

Supervisor McGillicuddy led the Pledge of Allegiance.

3. ROLL CALL

The secretary called the roll of the Board.

4. PUBLIC REMARKS

Supervisor McGillicuddy opened Public Remarks.

Leonard Provencher, 5824 Buena Parkway, Haslett, shared his letter to the editor in the August 4th edition of the *Lansing State Journal* regarding Meridian Township voters having a choice in whether to support Board members who voted to support "big business" (Phase 2 of the Lodges of East Lansing). He put Board members on notice that he intended to follow through on a statement he made last fall that he would be grading their performance in upcoming Board meetings.

Neil Bowlby, 6020 Beechwood Drive, Haslett, spoke to Board changes to the Planning Commission version of the urban services boundary.

Craig Philips, 2130 White Owl Way, Okemos, requested the Board ask the Ingham County Department of Transportation and Roads (ICDTR) to remove two "nuisance" stop signs on Hamilton Road immediately east of Okemos Road as they increase traffic congestion at the intersection of Okemos Road and Grand River Avenue.

Supervisor McGillicuddy closed Public Remarks.

5. REPORTS/BOARD COMMENT/NEW WORRIES

Supervisor McGillicuddy reported her attendance last week at the monthly Urban Services Management Committee. She also noted Capital Area Transportation Authority's (CATA) Bus Rapid Transport Committee met and will be submitting a new application later this year for bus rapid transport.

Trustee Ochberg reported her attendance at the last Planning Commission and indicated Commission members may attend the Board meeting en masse when the urban services boundary is before the Board. She stated the Planning Commission consensus was that the Township Board failed to use the ten (10) criteria set up by Tri-County Regional Planning Commission's (TCRPC) Urban Services Management Committee for making decisions.

Treasurer Brixie attended the walkability audit for the DDA as well as the DDA meeting. She made an announcement on behalf of Capstone Collegiate Communities inviting citizens to a pre land clearing harvesting event on Friday, August 31, 2012 from 9:00 AM to noon at the Lodges of East Lansing Phase 2 site (southeast corner of Hannah Boulevard and Eyde Parkway). Capstone has requested residents bring their own buckets, shovels, etc.

Trustee Dreyfus announced Trustees are being bombarded with form e-mail petition signatures (over 600 to date) in support of the Douglas J mixed use planned unit development (MUPUD). He spoke to the inappropriateness of these emails being timed in one minute increments.

Treasurer Brixie clarified that of the emails she has read regarding the Douglas J project, over half of the petitioners were including personal comments in support for one of the oldest businesses within the community.

Trustee Ochberg remarked that she attended the DDA walkability audit in a wheelchair to assess handicap accessibility. She expressed appreciation for Mr. White's provided synopsis of discovered pros and cons from the audit. Trustee Ochberg noted the sewer grates and detectable warning plates for the blind are difficult to navigate in a wheelchair.

Craig Phillips, 2130 White Owl Way, Okemos, spoke in strong support of the effort to control deer population in Meridian Township.

Supervisor McGillicuddy closed Public Remarks.

A. 2012 Deer Management Plan

Jane Greenway, Parks and Land Management Coordinator, presented and overview of the 2012 Deer Management Plan. She noted this is the second year of the deer management plan.

Treasurer Brixie moved that the Meridian Township Board, recognizing that controlled hunting in township-owned properties may help control the overpopulation of white-tailed deer, authorize staff to conduct managed hunts from October 1, 2012, through December 31, 2012, and also during the early antlerless season on September 22 and 23, 2012, at the following properties:

- Appreciation to staff for the program
- Preference staff will devise a plan next year to address deer who reside in subdivisions
- Staff ability to provide residents with the names of approved participants who could hunt on their property
- Question on the state's volunteer registration form speaks to the hunter placing his/her name on a list that can be provided to private homeowners
- Availability of information on the Township website

- Process to match neighborhoods up with hunters
- State does not allow hunting within 450 feet of a occupied dwelling without written permission
- Inquiry if program will be expanded in the future to non-resident hunters
- Move to archery "only" addresses any noise or safety issue
- Suggestion that Township approved hunters wear orange to identify themselves
- State rule that bow hunters are not required to wear orange unless it is during firearm season

11. DISCUSSION ITEMS/ENDS

Supervisor McGillicuddy opened Public Remarks.

Neil Bowlby, 6020 Beechwood Drive, Haslett, expressed appreciation to Manager Richards for his innovative approach to online access of Board packets.

Leonard Provencher, 5824 Buena Parkway, Haslett, spoke in support of the complete streets ordinance while expressing concern with the implementation and execution portions of the ordinance. He indicated his desire for Board oversight to ensure implementation to the fullest extent possible.

Supervisor McGillicuddy closed Public Remarks.

A. Complete Streets Ordinance

Board members discussed the following:

- Support for this long overdue ordinance
- Ordinance will improve the walkability of the community
- Boulevards with landscaping (trees), when appropriate, adds value, slows down traffic, provides a cooling effect, is visually aesthetic and ties into the complete streets concept
- Appreciation for inclusion of suggestions which makes action more definitive
- American Association of State Highway and Transportation Officials (AASHTO) standards do not require a 20 foot boulevard
- Some sections were written in a broad format as the Township does not have the ability to regulate the road right-of-ways
- Possible insertion of median/boulevards in Section 58-38 (3)
- Possibility of staff raising the issue of median/boulevards with road agents when the projects are proposed

It was the consensus of the Board to place this item on for action at the September 4, 2012 Board meeting.

B. Online Access to Board Packets

Township Manager Richards summarized a potential process for online access to Board packets as outlined in staff memorandum dated August 17, 2012.

Board members discussed the following:

- Packets delivered to Board members after 5:00 P.M. on Fridays
- Board members preference for on-line access at 8:00 P.M. on Friday

It was the consensus of the Board to direct staff to provide an online Board packet by 8:00 P.M. on Fridays before a Board meeting.

12. PUBLIC REMARKS

Supervisor McGillicuddy opened Public Remarks.

Rick Leeper, 2109 Lac Du Mont, Haslett, spoke to Fireworks being set off on New Year's. He addressed what an apartment complex in the Hiawatha/Chippewa Hills neighborhood along the Red Cedar River would do to the community, suggesting it would become a blight in two years. Mr. Leeper suggested a drive-in theatre and amusement park as development projects which would bring money into the community.

Neil Bowlby, 6020 Beechwood Drive, continued his earlier public comment regarding Board extension of the urban services boundary recommendation sent to the Board by the Planning Commission. He also discussed Ingham County's point of sale program.

Leonard Provencher, 5824 Buena Parkway, Haslett, reported his attendance at the DDA's walkability audit. He expressed concern that traffic continues to turn when pedestrians have the walk signal at the southeast corner of Okemos and Hamilton Roads, creating a dangerous situation. Mr. Provencher believes concern with safety should be primary over traffic backup.

Supervisor McGillicuddy closed Public Remarks.

13. FINAL BOARD MEMBER COMMENT

Trustee Ochberg requested clarification on the Township's process when a citizen requests sewer extension, including how the extension is financed.

14. ADJOURNMENT

Supervisor McGillicuddy adjourned the meeting at 7:00 P.M.
