F. Township Board Request to the Planning Commission to allow Bed & Breakfast use in Residential and Commercial Zones as a Special Use

Trustee Brixie moved to request the Planning Commission initiate a zoning amendment to Section 86-403 C-1 (Commercial) district, Section 86-404 C-2 (Commercial) district, Section 86-405 C-3 (Commercial) district, and Section 86-654 Nonresidential structures and uses in residential districts of the Code of Ordinances to permit by special use permit a bed and breakfast. The Planning Commission is further instructed to determine if any additional standards or requirements specific to a bed and breakfast need to be added to the Code of Ordinances to ensure a bed and breakfast is a compatible use in the designated zoning district. Seconded by Trustee Such.

7. TOWNSHIP HALL MEETING

A. Linking with our Community – An Open Dialogue Supervisor McGillicuddy opened the Town Hall Meeting.

Dianne Holman, Ingham County Commissioner for the northern portion of Meridian Township, 4681Van Atta Road, Okemos, discussed the following items:

- Her interest in public comment from other Town Hall meeting attendees
- Her interest in hearing how the county can work with the Township on mutual projects and promote community character and improvement through "sustaining communication"
- Three year Transportation Improvement Plan (TIP) comes from the 25 year overall Tri-County Regional Planning Commission Transportation Plan
- Public interaction with her to promote ideas
- A community approach to the entire Okemos Road Corridor
- North Okemos Road as a large and complicated project

John Anderson, 215 W. Newman Road, Okemos, discussed the following items:

- Alleged continued decline in the Township's fund balance
- Township affordability of the Okemos Road Median Project
- Potential plans for the property owned by the Township west of Meridian Mall which is zoned multiple family
- Alleged conflict in the Mixed Use Planned Unit Development Ordinance
- Possible expansion of the Haslett Library
- Alleged over commercialization in the Township has led to a decline in property values

Leonard Provenchur, 5824 Buena Parkway, Haslett, discussed the following items:

• Alleged poor announcement process regarding the Town Hall Meeting

- Board concentration on infrastructure prior to development
- Board action does not lend itself to a smart growth pattern

- Change in language from aesthetic to enhancement for the Okemos Road Median Project
- Range of reports on the Township's website

Richard Harrington, 820 Piper Road, Haslett, discussed the following items:

- Objection to the look of the eagle icon at the north entrance of the Meridian Municipal Building
- Desire for two percent (2%) of the Township's budget be earmarked for the arts

Supervisor McGillicuddy requested Township Manager Richards clarify inaccuracies stated during public comment.

Township Manager Richards announced advanced copies of the Meridian Monitor and additional copies of the 2006 edition of the *Meridian Community Volunteer Guide* were available to the public at the meeting.

Trustee Veenstra announced some members of the Board will be meeting with the Ingham County Road Commission at a meeting to be held on August 3, 2006 at the Road Commission offices in Mason. Trustee Veenstra felt this might be the proper forum to bring up issues such as the timing of the North Okemos Road project. He indicated he would place the highest priority on spending road funds to repave some of our existing roads where the pavement is in such poor condition that they are problematic for bicyclists.
