8. TOWN HALL MEETING

Supervisor McGillicuddy opened the Town Hall Meeting. She noted the steps taken to address resident concerns with train noise as expressed at the August 9, 2001 Town Hall Meeting.

Manager Richards discussed ongoing research of state and federal laws and available methods to resolve the train noise issue.

Ken Stoffer, 75 Nature Way, Okemos, discussed the following items:

- Unsuccessful experiment with chip sealing of roads in his subdivision
- Need to address the deterioration of roads in his subdivision

Charles Louis Willems, 1387 Hickory Island, Haslett, discussed the following items:

- The Board's role as a policy making body
- Basic rights of citizens under the constitution
- Errors in Township Assessing records as to the existence of municipal water on Hickory Island, division of abandoned alley on Hickory Island, and ownership of a strip of land between his homestead and Lake Lansing

Supervisor McGillicuddy asked Manager Richards to look at the status of the Assessing records to correct any errors relevant to Mr. Willems property interests. She commented on her unsuccessful attempts to end chip sealing in subdivisions.

Manager Richards discussed the need to address the growing issue of road deterioration significantly in the 2003 budget. He encouraged Board Members and residents to attend a rally at the Capitol steps Tuesday, August 13, 2002 at 9:00 A.M., to show support for continued funding of municipal services. He discussed the financial significance to the Township of the loss of approximately one million dollars in state revenue sharing.

John Veenstra, 320 Piper Road, Haslett, discussed the following items:

- Township incorporation into a city as a means to control road construction standards and funds
- Extension of library hours to maximize use of the facilities
- Support for increased recycling programs and convenience
- Need for bicycle parking standards in the ordinance
- Need for the creation of a Bicycle Advisory Committee
- Opposition to amendments to the Rental Housing Program

Supervisor McGillicuddy thanked the participants of the meeting.
